The meeting was called to order by the Chiarman and the invocation was given by The Reverend David Jay, Director, Good Shepherd Home, Lake Waccamaw.

The following business was transacted:

The minutes of the September 2nd, 6th and 12th were approved as recorded upon motion by Commissioner Dew and seconded by Commissioner Hinson.

A report was presented to the Board by Commissioner McPherson and John Yates on reccommended ratings of the Water Resources Projects & Programs which are located in Columbus County. The N. C. Department of Natural Resources & Community Development had requested aid to help finalize a priority list. After a discussion of the Projects the following ratings were approved by the Board upon motion by Commissioner McPherson and seconded by Commissioner Dew:

WHEREAS, the Riegelwood Sanitary District has prepared a plan for wastewater management in the Riegelwood Facility Planning Area.

WHEREAS, the Plan recommends formation of a Sterring Committee on Wastewater Management, to be composed of local and County Officials, to implant the Plan;

WHEREAS, the plan recommends that certain data related to wastewater management (either presently collected or to be collected by existing County Departments or Commissions) be reported to the Steering Committee for their use in studying wastewater treatment needs in the area;

NOW, THEREFORE, BE IT RESOLVED that the Columbus County Board of Commissioners endorses the WASTEWATER MANAGEMENT PLAN FOR THE REIGELWOOD PLANNING AREA (June, 1977) as the official plan for wastewater management in the area;

FURTHER, that the County Board of Commissioners pledges its assistance in implementation of the Plan by providing such data as may be required and available from County departments or commissions to assist the Steering Committee on Wastewater Management in studying wastewater treatment needs in the Planning Area.

A motion was made by Commissioner McPherson, seconded by Commissioner Dew and approved to allow the Finance Officer to void checks outstanding in the Undistributed Tax Account and the Medicaid Fund as follows:

Finance Officer as persons to draw on the Cited Letter of Credit for the Community Development Grant and the County Attorney is hereby designated to certify the signatures.

At 11:00 a.m. tha Chairman announced that it was the appointed time to open bids for the sale of the 1974 pick-up truck at the landfill.

There was a discussion of the above bids for both the containers and the trucks.

A motion was made by Commissioner McPherson, seconded by Commissioner Williamson and passed to reject all bids for the present time.

Mr. Curtis Wellbourne, Chiarman, American Red Cross for Columbus County, met with the Board and requested continued support of the Red Cross and ask for a financial contribution in the amount of \$1,000 to the fund drive which is now underway. He discussed the services offered by the Red Cross and also programs they wished to implement in the future when funds become available. The Board informed Mr. Wellbourne the matter would be discussed with the County Attorney before a decision is made.

The Reverend David Jay, Director, Good Shepherd Home, Lake Waccamaw, met with the Board to request assistance to the Home, either CETA workers and/or financial aid. He commented on the work the Home gives to rehabilitate alcoholics and that the need was great. This matter will also be discussed with the Attorney.

The Chairman had received information from the North Carolina Arts Council that Columbus County could apply for a grant in the amount of \$2,464.88 for Grassroots Arts Programs. By general agreement the Board contacted Edd Miller with the Oriatoria Society, to apply for the funds, along with ther eligible agencies.

There was a discussion concerning the Board signing for application for a loan through FmHA to build a library building in the Riegelwood area. The Acting Attorney advised the Board to delay action on the issue until the Attorney could be present. It was further stated that the Board of Trustees be made aware of the request as it would be of future concern to them.

At the designated time to open bids for the repairs of the outside of the Courthouse; no bids were received. This was the second time advertisement had been made for this work whit no response from qualified contractors.

Upon motion the meeting adjourned until 2:00 p.m., Tuesday, September 20, 1977, to continue unfinished business.
