A motion was made by Commissioner Williamson, seconded by Commissioner Dew that the extinguishers be purchased from the low bidder which is Strickland's Fire Extinguisher Service of Cerro Gordo.

Bowers, Airport Authority Chairman, and discuss the possibility of the County assisting with the purchase of airport terminal furniture and offer the trailer located at the airport in exchange for one of the trailers owned by the Board of Education. The Chairman was asked to discuss the matter with the Board of Education and relay the fact that if the trailers are moved from the zoned area that no trailer replacement can be made in that area.

The Chairman was also asked to get a price from Crowell Construction Company for the cost of paving parking lots and driveways at the County Hall.

The WATS line report was presented to the Board stating that the line was still being used by the citizens and also officers throughout the County.

Information was given to the Board Members on appointing a Nursing Home Community Advisory Committee which must be done in the near future.

The following Resolution was adopted upon motion by Commissioner Hinson and seconded by Commissioner Williamson relating to open meeting laws:

All special meetings of the Board of County Commissioners of Columbus County, North Carolina, are held at the same location for regular meetings. If a special meeting  $\checkmark$ 

is to be held, the place of the said regular meeting and the time of the special meeting

of the Board of County Commissioners of Columbus County will, within forty eight (48) hours before the meeting, be posted on the Board's principal bulletin board which is at the first floor, rear centrance to the Administration Building, Washington Street, Whiteville, North Carolina. In addition thereto, the Board will mail or deliver to each news media which has requested notice of the said special meeting. It is understood that the Board of County Commissioners of Columbus County will not charge any amount of money for the mailing of written notice of any special meetings to any of the news media; however, it is understood that any of the respective news media shall be responsible for all long distance phone calls made for their benefit to notify them of any special meeting of the Board of County Commissioners, the Board of County Commissioners of Columbus County, North Carolina, pursuant to the Emergency meeting provision of the new law, is defining "Local News Media" as all Columbus County newspapers provided a request notice is submitted to the said Board, the <u>Wil-</u> mington Morning Star, and the <u>Fayetteville Observer</u>.


