The Honorable Board of County Commissioners met in their said office at 10:00 a.m., October 5, 1981, it being first Monday.

The meeting was called to order by the Chairman and the invocation was given by Commissioner Hinson.

The minutes of the September 21st meeting were approved as recorded upon motion by Commissioner Norris and seconded by Commissioner Hinson.

A motion was made by Commissioner Marlowe, seconded by Commissioner Dew and passed to appropriate \$1,500.00 in matching funds to pay the County's share of court ordered funding for one year enrollment of a juvenile in a Community Based Alternative Program for preparation for independent living.

A letter was presented to the Board from Columbus County Ministerial Association requesting that SR1554 be paved. This is a road that is traveled by ministers that visit the Hill Top Rest Home. This request was presented to the Department of Transportation officials at the September 28th hearing for Secondary Roads Improvement Program for 1982.

A motion was made by Commissioner Hinson, seconded by Commissioner Marlowe and passed to accept the resignation of John Spaulding, Agriculture Extension Agent, with regrets.

Mr. Spaulding resigned for health reasons.

Philip McPherson, representing Columbus Christian Action Council, met with the Board and made a slide presentation to the Board entitled "Abortion - How It Is" narrated by Dr. and Mrs J. C. Wilk. After the presentation Mr. McPherson again requested that the Board refuse to accept state funds for abortions. There was further discussion on the subject. Mr. McPherson asked the Board to meet with the Council's lawyer and stated that he would relate to the Board how they could legally refuse state abortion funds. The Board response was that they were accepting the advice of the County Attorney and the State Attorney General's Office that the County is legally bound to offer the service to indigent persons. Commissioner Hinson suggested that the Council take their case to the courts attack the law rather than attack the Board of Commissioners who is not responsible for the legislation or the directives from DHR.

A motion was made by Commissioner Dew to table the subject until such time as the Legislators direct the Board to delete the funds from their budget and the Chairman announced that the matter is tabled.

At 10:45 the Board recessed until 11:00. Attorney Hill came to the meeting at this time but was called to court on a County matter.

Chuck Wheeler, of Wheeler Chevrolet Company, met with the Board to complain about the manner in which the County purchased two pick-up trucks in August. His contention was that all information should have been included in the bid and not accepted any changes after the bids were opened. The Board explained that the purchases were made in the best interest of the County and that the rebate program was extended with the Ford Motor Company through the time of the bids which allowed \$300.00 rebate on each vehicle. Also, one of the trucks bid by Wheeler Chevrolet did not meet the minimum standards of the bid specifications.

Ila Penny, Register of Deeds, met with the Board to ask their approval of asking for a management study of the Office of Register of Deeds from the Department of Administration as provided for in NCGS 143-345.6.

A motion was made by Commissioner Dew, seconded by Commissioner Hinson and passed to jointly make the request to the above Department for the survey.

There was a discussion concerning the Sheriff's Department being added to the study for personnel classification and pay plan. The Department had been included in the contract for the study that has just been completed by the Office of State Personnel but would not participate even though funds were paid for the inclusion. No action was taken on this matter.

Keith Lewis, Program Director for Chemical Dependency Center in Fayetteville, met with the Board to request their support in their application to the Cardinal Health Agency to open an additional center in Wilmington. The Center is a private organization and does not require any local funds.

The following resolution was unanimously passed upon motion by Commissioner Norris and seconded by Commissioner Hinson;

WHEREAS, there is in Southeastern North Carolina a great need for rehabilitation in the drug and alcohol related programs; and

WHEREAS, Keith G. Lewis, C. A. C., is presently applying for a Certificate of Need through the Cardinal Health Agency for the establishment of a Chemical Dependency Center in Wilmington, North Carolina, for treatment of in-patients with drug or alcohol related problems;

BE IT, THEREFORE, RESOLVED by the BOARD OF COUNTY COMMISSIONERS OF COLUMBUS COUNTY, NORTH CAROLINA that they unanimously endorse the application for the Certificate of Need by Keith G. Lewis for the establishment of a Chemical Dependency Center in New Hanover County, North Carolina and request that the Cardinal Health Agency Board approve said Certificate.

On September 28th the Board met jointly with officials of the Department of Transportation, B. A. Mills, District Engineer; Lenwood Rich, Member, Board of Transportation, and E. J. Butler, Division Engineer. The meeting was a public hearing for the purpose of allowing the citizens of the County to be heard concerning secondary roads' improvements for the 1982 fiscal year.

The Secondary Roads Program was presented to the Board of Commissioners for approval at this time. The following resolution was approved by the Board and reconfirmed at this meeting:
