The meeting was called to order by the Chairman and the invocation was given by Commissioner Hinson.

The following business was transacted:

The minutes of the February first meeting were not approved at this time.

The following proclamation was presented to the Board by Jimmy Rogers, Tabor City School, and Kipling Godwin, Williams Township School:

FUTURE FARMERS OF AMERICA PROCLAMATION

WHEREAS, the Future Farmers of America with vocational agriculture education is a strong force for America's agriculture; and

WHEREAS, members of the FFA are playing an outstanding role in assuring the future progress and prosperity of our nation; and

WHEREAS, the FFA motto - 'Learning to do, doing to learn; earning to live, living to serve'' - gives a direction of purpose to these future leaders for tomorrow's agriculture; and

WHEREAS, the FFA performs the valuable service of developing leadership, encouraging cooperation, promoting good citizenship, teaching modern agriculture information, and inspiring patriotism among members,

THEREFORE, I, Junior Dew do hereby designate the week of February 20-27, 1982, as FFA WEEK.

The above proclamation was passed upon motion by Commissioner Hinson and seconded by Commissioner Williamson.

Corbett Fields met with the Board and presented a request that SR 1515 be closed. He presented a statement with signatures of residents living in the area which stated that

they approve the closing of the Road. He also presented a map showing the location of the

Road which cuts through his farm and no other person owns property that joins the Road.

District Engineer Andy Mills was also present at the meeting to hear the present-

ation. The County Attorney reviewed the procedures for closing a road that is maintained

by the State Department of Transportation.

A motion was made by Commissioner Marlowe, seconded by Commissioner Williamson and passed that proceedings begin by requesting that the Department of Transportation delete SR 1515 from the State maintained system. Further action will be taken depending on the de-

cision of the Department of Transportation.

A motion was made by Commissioner Marlowe, seconded by Commisioner Williamson and passed approving the Department of Transportation deleting SR 1174 from the work order for improvements due to not being able to obtain the rights-of-way.

A letter was presented to the Board from Abby Butts, Riegelwood, requesting that the Board pass an ordinance to either keep dogs on a leash or be kept inside a fence. She is requesting this for the Riegelwood area only. She stated that they have serious problems with large dogs which are dangerous to children and adults. The Attorney stated that he felt the problem could be taken care of through present State laws. He was designated by the Board to discuss the problem with the Dog Warden.

The following resolution was passed upon motion by Commissioner Marlowe and seconded by Commissioner Williamson to continue the Section Eight Rental Assistance Program with HUD:

RESOLUTION AUTHORIZING EXECUTION OF AN ANNUAL CONTRIBUTIONS CONTRACT FOR COLUMBUS COUNTY, NORTH CAROLINA

WHEREAS, the County of Columbus proposes to enter into an Annual Contributions Contract with the United States of America, Department of Housing and Urban Development;

NOW, THEREFORE, BE IT RESOLVED by the County of Columbus, PHA, as follows:

Section 1. The Contract, numbered Contract Number A 3242, is hereby approved and accepted both as to form and substance and the Housing Program Director is hereby authorized and directed to execute said Contract in triplicate on behalf of the PHA, and the Clerk to the Board of County Commissioners is hereby authorized and directed to impress and attest the official seal of the said PHA on each such counterpart and to forward said executed counterparts to the Government together with such other documents evidencing the approval and authorizing the execution thereof as may be required by the Government.

Section 2. The Housing Program Director is hereby authorized to file with the Government from time to time, as monies are required, requisitions together with the necessary supporting document, for payment under the Contract.

Sections 3. This Resolution shall take effect immediately.

Commissioners Marlowe, Hinson and Dew voted in favor of tabling the motion.

Commissioner Williamson voted against tabling the motion.

A motion was made by Commissioner Williamson, seconded by Commissioner Hinson and passed that Peggy Fields be allowed to return to full time employment in the Tax Collector's Office as requested by Mr. Enzor, Tax Collector. Mrs. Fields has been working a four-day week.

The following tax releases were approved upon motion by Commissioner Williamson, seconded by Commissioner Hinson and recommended by Ralph Jolly, Tax Supervisor:

There was a meeting of Department Heads at 11:30 a.m. and the following persons were present: Emogene W. Suggs, Stuart Sasser, Evelyn Rabon, Tracy Floyd, Roscoe Enzor, Ralph Jolly, Hobson Ivey, Howard Stanley, Irene Young and Marion Duncan.

The main topic of discussion was a request by Howard Stanley that all accident

reports be made promptly, both on County employees and other persons injured on County property.

It was also discussed that better lighting should be installed in the Commissioners meeting

room and Tracy Floyd was asked to determine the cost to install fluorescent lights over

the Commissioners' desk.

The Attorney was asked to look into the medical coverage section of the liability

insurance policy for the Sheriff's Department and advise the Board at the next meeting if he

feels that it is desirable to continue the coverage of this section.

Howard Stanley informed that it is recommended by OSHA and the Insurance carriers that there be two persons in each County Building that has had training in first aid. Mr. Stanley was asked to contact employees in each building to find out how many persons would need to be trained if the recommendation is adopted. He is to report to the Board at the next meeting on his findings.
