The meeting was called to order by the Chairman and the invocation was given by the Reverend Roy Walker, Pastor, First Baptist Church, Whiteville.

The minutes of the March 15th meeting were approved as recorded upon motion by Commissioner Hinson and seconded by Commissioner Marlowe.

Susan Harmuth, Director, RSVP, met with the Board to present their budget request for 1982-83 which is the same as the current year, \$10,000.00. She reviewed the programs that are now being operated by RSVP. The Board agreed to consider the request at budget sessions. Ms. Harmuth was accompanied by Sara Stroud, Secy., RSVP, Goldie Johnson, and Myrtis Milligan.

The following tax releases were approved upon motion by Commissioner Williamson, seconded by Commissioner Marlowe and recommended by the Tax Supervisor:

Ordered: that a refund be given to Sarah Jenkins Battle, Cerro Gordo Township, in the amount of \$6.45 due to taxes paid in error for Mary F. Graham, for 1981 taxes.

A motion was made by Commissioner Hinson, seconded by Commissioner Williamson and passed to sign a contract with Don Viets to act as 4-D attorney for the Department of Social Services. Mr. Viets replaces Mr. Allen Maxwell who has resigned.

A motion was made by Commissioner Norris, seconded by Commissioner Marlowe and passed to amend the budget for the Recreation Department in the amount of \$173.00 for services to "call" ball games - 620-45; the funds are from donations.

It was further ordered that the Health Department budget be amended in the amount of \$3,000.00 for the Tuberculosis Clinic Operating Expenses and the funds are totally State funds.

A motion was made by Commissioner Williamson, seconded by Commissioner Hinson and passed to hire an additional Eligibility Specialist at the Department of Social Services due to the increase in food stamp applicants.

A motion was made by Commissioner Marlowe, seconded by Commissioner Norris and passed to accept the HUD Section Eight Rental Assistance Budget Estimate to be reviewed in detail at the time the total county budget is processed.

A motion was made by Commissioner Hinson, seconded by Commissioner Williamson and passed to hire a general laborer at the Landfill to be paid at the minimum wage.

The following resolution was passed upon motion by Commissioner Hinson, seconded by Commissioner Marlowe and approved by the County Attorney:

RESOLUTION REQUESTING AND APPROVING THE APPLICATION OF THE NORTH CAROLINA HOUSING FINANCE AGENCY IN THE FINANCING OF AND ADMINIST-RATION OF SECTION 8 FEDERAL HOUSING ASSISTANCE WITH RESPECT TO, A HOUSING PROJECT TO BE LOCATED IN THE CITY OF WHITEVILLE, N.C.

BE IT RESOLVED BY THE COLUMBUS COUNTY BOARD OF COMMISSIONERS;

Section 1. The participation of the North Carolina Housing Finance Agency in the financing of, and administration of Section 8 Federal Housing Assistance with respect to the proposed housing project for occupancy by persons and families of lower income (as defined by the Agency) described below and located at Nolan Road next to the City Park in the City of Whiteville, is hereby requested and approved pursuant to G. S. 122A-5(1):

Description of Proposed Project:

An apartment complex consisting of 26 units in five buildings primarily for residence by families.

The above resolution was presented to the Board by Pat Burns, representing Phoenix Development Associates, Inc., Raleigh, NC.

A motion was made by Commissioner Hinson, seconded by Commissioner Norris and passed that upon the signing of the PROMISSORY NOTE for \$1,500.00 by LAKE WACCAMAW DEVELOPMENT CORPORATION's President, the funds be forwarded to the Department of Transportation in the amount of \$58,716.44 for participation in paving the Waccamaw Shores Road. The above amount is a correction of the amount stated in the resolution of the March 15th meeting page 533 of Minute Book XVIII. Also the amount of the rate of participation stated in the resolution as two dollars per lineal centerline foot should be four dollars per lineal centerline foot. This action was taken upon the advice of the County Attorney to proceed with the Waccamaw Shores Road Project and to account for the funds that will be payable to the County for the advancement of the funds.

Afmotion was made by Commissioner Marlowe, seconded by Commissioner Williamson and passed to appropriate \$1,385.00 from Surplus to purchase a radio for North Whiteville Volunteer Fire Department from the General Electric Company.

A motion was made by Commissioner Williamson, seconded by Commissioner Marlowe and passed to appropriate \$1,325.00 from Surplus to purchase a radio for the N. C. Forest Service, in Columbus County, from the General Electric Company.

The above requests were presented to the Board by Howard Stanley, Ed Worley,

Arthur Horton and Melvin Brown. Informal bids were presented from General Electric, Regency,

and Motorola.

A motion was made by Commissioner Norris, seconded by Commissioner Hinson and passed that Howard Stanley be delegated to respond to the finding by the Aetna Insurance Company and make the necessary safety improvement at the repeater station at a cost of approximately \$150.00 to be charged to the Emergency Management budget.

Mr.Stanley discussed the matter of workers'compensation for volunteer firemen in the County and asked that the Board check to find out which units have their own insurance policy so that we can report to the County's carrier.

A motion was made by Commissioner Norris, seconded by Commissioner Williamson and passed that each department head be asked to do a monthly safety inspection of their respective department. The guidelines will be furnished by Howard Stanley.

A motion was made by Commissioner Williamson, seconded by Commissioner Marlowe and passed that the following proclamation be adopted:

WHEREAS, our emergency medical services system provides life-saving care to the citizens of Columbus and surrounding Counties; and

WHEREAS, numerous emergency medical technicians, emergency department physicians, paramedics, and nurses are trained in avariety of emergency medical techniques; and

WHEREAS, a great number of our citizens have been trained in cardiopulmonary resuscitation so that they may help their fellow citizens in time of need; and

WHEREAS, a large number of citizens unselfishly volunteer their time to provide valuable service to their fellow citizens; and

WHEREAS, recognition is due these volunteers who serve on behalf of the citizens of Columbus and surrounding Counties;

NOW, THEREFORE, WE, THE COLUMBUS COUNTY BOARD OF COMMISSIONERS, join with the State of North Carolina and other Counties, and do hereby proclaim the week of April 25 through May 1, 1982, as EMERGENCY MEDICAL SERVICES WEEK in Columbus County and commend this observance to our citizens.

/s/ Junior Dew, Chairman Board of Commissioners A motion was made by Commissioner Hinson, seconded by Commissioner Marlowe and passed that the 4½ acres of County property that joins Legion Stadium be transferred, by deed, to the Whiteville Board of Education for development by the City Schools for recreational purposes. The request was made by Supt. Paschal, Clyde Williams and David McPherson on behalf of the Schools. (RECORDED IN BOOK 340, PAGE 63/)

It was stipulated that any funds received from the timber on the above be deposited in the County's General Fund.

A motion was made by Commissioner Norris, seconded by Commissioner Hinson and passed that Commissioner Williamson attend the meeting in Winston-Salem, as requested by the School officials, concerning some of the school programs. Members of the schools' administration will also attend.

A motion was made by Commissioner Hinson, seconded by Commissioner Williamson and passed that the County purchase maintenance agreements for automobile repairs on 17 vehicles at the Sheriff's Department beginning with 1981 models. The plan agreed on for miles purchase is the Power Train Plan; 5 year/50,000/with \$50.00 deductible. Funds are to be appropriated from Surplus for this expense.

A letter was read to the Board from the Library Board of Trustees, requesting an additional position to assist the children's librarian to maintain the present level of services to the children in the County.

No action was taken at this time but will be considered at budget time.

A letter was read to the Board from Garland McCullen, Extension Chairman, requesting that he be allowed to use funds he has in his budget, because of the vacancy from John Spaulding's retirement, to increase the salaries of Linda Brulet, Linda Lee, Dorothy Reaves and James Norris in the amount of \$75.00 per month each.

A motion was made by Commissioner Williamson to grant the request. There was no second to the motion and no vote.

A motion was made by Commissioner Williamson, seconded by Commissioner Marlowe and passed to allow the Finance Office to purchase a calculator and to amend the budget to cover the cost. This calculator is to replace one that belonged to CETA and has been picked up by the CETA office.

The Board discussed re-roofing the Law Enforcement Center which has been patched during the winter. The Clerk was asked to contact Sunbelt Roofing Service, Inc., Marion, S. C. to get a bid on the roofing that had been discussed earlier in this meeting by Randy Wesley, Salesman. There was also a bid from E. L. Hawks Roofing in Whiteville. The Attorney also requested a copy of the warranty from Sunbelt Roofing.

The Tax Collector's Report for the month of March was presented to the Board.

The collection rate for 1981 taxes is now 89.29%.

Commissioner Hinson was asked to attend the Hazardous Waste meeting in Greenville, N. C. to represent Columbus County.
