The Honorable Board of County Commissioners met in their said office at 10:00 a.m., October 18, 1982, it being third Monday.

The meeting was called to order by the Chairman and the invocation was given by Commissioner Hinson.

The following business was transacted:

The minutes of the meeting of October 4th, 8th and 13th were approved as recorded upon motion by Commissioner Hinson and seconded by Commissioner Norris.

A letter was presented to the Board concerning the available office space at the Courthouse. Commissioner Dew had met with Mike Easley, Assistant District Attorney; Lacy Thompson, Clerk of Superior Court; William G. Rhodes, Sheriff Nominee; and Frank Stanley, President of Columbus County Bar Association to discuss the assignment of office space in the Courthouse. Those meeting with Mr. Dew agreed on the assignment of space as was set out in the letter but did not contain signatures of those listed above as requested by Mr. Dew. The Clerk was instructed to contact those who had not signed the letter before November 1, 1982, and at that time the Board will take action on the assignment of office space.

Commissioner Marlowe came to the meeting at 10:20.

The following persons met with the Board and presented further information concerning the building of two facilities, one at Old Dock and one at Chadbourn Elementary Schools: Mitchell Tyler, Supt., Columbus County Schools; John F. Carter and Walter Batten, Members of Board of Education; Edward L. Williamson, Attorney for Board of Education; Robert Ezzell, Finance Officer for Schools; Bill Brown, Architect, Littles & Associates; J. C. Formyduval, Principal, Old Dock School; C. W. Williams, Principal, Chadbourn Elementary School; Willie J. Wall, Advisory Board Member at Chadbourn School and Fred Tedder, Maintenance Supervisor for the County Schools.

A presentation was made by Mr. Brown showing the building plans and various alternatives and options that could be made to adjust to the available funds if funds are not available to finish both buildings. He stated the completed buildings would cost an estimated \$219,000 each but with certain deductible alternates could be built for \$200,000 each. He also stated that if two projects were started at the same time there would be a savings of about \$25,000. No committment was made by the Board at this time but they told the group that they would give them an answer within two weeks.

A motion was made by Commissioner Hinson, seconded by Commissioner Marlowe and passed to make the following changes: Add \$50,000.00 to the contents of the PCA Building; Get County Hall and Miller Buildings re-rated because of the changes in heating and cooling systems at both buildings; Add contents to the Riegelwood Branch Library after consulting with the Library Director, Amanda Bible.

There was a short discussion concerning the liability insurance for public officials and county employees. Attorney Hill recommended that the County obtain retroactive coverage

to cover any claims that may be made against the County in the change over from a "claims made" policy to an "occurrence" policy.

A motion was made by Commissioner Hinson, seconded by Commissioner Norris and passed to add the above coverage.

Commissioner Dew stated that he was in the process of finding office space for the Employment Security Office in Chadbourn and had three places to visit that could be made available to the County for office space. A letter was presented to the Board which had been written to the Employment Security Commission Office in Chadbourn from the White-ville Chamber of Commerce asking that the Office be moved to Whiteville as Whiteville is the County seat and is centrally located.

Upon motion the meeting adjourned until November 1, 1982, at 10:00 a.m. which is regular meeting time.
