The Honorable Board of County Commissioners met in their said office at 10:00 a.m., November 1, 1982, it being first Monday.

The meeting was called to order by the Chairman and the invocation was given by Father Robert Schriber, Grace Episcopal Church.

The following business was transacted:

The minutes of the October 18th and 25th were approved as recorded upon motion by Commissioner Hinson and seconded by Commissioner Norris.

A motion was made by Commissioner Marlowe, seconded by Commissioner Hinson and passed that the Chairman be authorized to sign the APPLICATION FOR CERTIFICATION for the Youth Task Force to apply for \$250.00 in administrative funds that were not used in the past fiscal year for Community Based Alternatives programs.

A motion was made by Commissioner Hinson, seconded by Commissioner Marlowe and passed that Richard Self be hired in the position of county administrator to begin work on November 15,1982.

A motion was made by Commissioner Hinson, seconded by Commissioner Norris and passed that the Department of Social Services be allowed to hire an eligibility Specialist for AFDC and Medicaid as the number of applicants have increased due to the economy. Also, instructions have been received from Department of Human Resources that the participation of the State in the Four-D Program has been cut from 75% to 70% and the County will have to pick up the additional 5%. Her total request will be \$8,985.52. Of this amount \$4,645.00 will be for the Four-D Program and the balance in salaries and fringe benefits for the two additional workers.

A motion was made by Commissioner Norris, seconded by Commissioner Hinson and passed that Jerry Ramsey apply for an extension of the Community Block Grant to replace two dwelling units with the remaining funds which is about \$5,000.00.

Mr. Larry Buffkin, Commissioner elect, was present at this meeting and the Chairman recognized him at this time.

Mr. Mitchell Tyler and other administrative officials from the County Schools, met with the Board to discuss further the request for funds to build two multi-purpose buildings, one at Old Dock School and one at Chadbourn School. The Board had promised them a response to the request at this meeting.

A motion was made by Commissioner Marlowe, seconded by Commissioner Hinson and passed that Edwin Tatum and Chief Doug Keller be appointed to the Youth Task Force.

There was a discussion concerning the request and the Board told the delegation that they would give them an answer by eight o'clock tonight, which is Board of Education meeting time.

Later in the meeting a motion was made by Commissioner Norris, seconded by Commissioner Marlowe and passed that the Board appropriate \$150,000.00 to the Board of Education to go as far as they can on one building and no further obligation be made on the other building due to the economy.

The following resolution was passed upon motion by Commissioner Norris and seconded by Commissioner Hinson:

WHEREAS, the Board of County Commissioners of Columbus County, proposes to enter into an Annual Contributions Contract with the United States of America, Department of Housing & Urban Development:

NOW, THEREFORE BE IT RESOLVED BY THE PHA as follows:

Section 1. The Contract, numbered Contract No.A3242, is hereby approved and accepted both as to form and substance and the Project Administrator is hereby authorized and directed to execute said Contract in triplicate on behalf of Columbus County, and the Clerk to the Board is hereby authorized and directed to impress and attest the official seal of the County on each counterpart and to forward said executed counterparts to the Government, together with such other documents evidencing the approval, and authorizing the execution thereof as may be required by the Government.

Section 2. The Project Administrator is hereby authorized to file with the Government, from time to time, as monies are required, requisitions together with the necessary supporting documents, for payment under the Contract.

Section 3. This Resolution shall take effect immediately.

This the 1st day of November, 1982.

Otis Collins, Administrator of HUD's Rental Assistance Program, met with the Board to request that the be allowed to hire an additional worker as they are applying for 35 additional units under the rental assistance program. The regional HUD office has approved an additional worker subject to the approval of the Board of Commissioners.

Mr. Collins also asked for an increase in salary for each worker in the local HUD office.

A motion was made by Commissioner Hinson, seconded by Commissioner Norris and passed to allow the HUD office to hire an additional worker. No action was taken on the request for increase in salaries.

Commissioner Marlowe who is a member of the local Health Board reported that they have not hired a new administrator for the Health Department but are interviewing applicants.

There was a discussion of the office space in the Courthouse. An agreement had been signed by the Clerk of Court, President of the Bar Association, Assistant District Attorney and the Sheriff Elect agreeing on space that they have requested. One item in the agreement has not been decided upon, i.e., a holding cell in the Courthouse to be used by the Sheriff when he brings prisoners to the Courthouse to be tried in court.

A motion was made by Commissioner Hinson, seconded by Commissioner Norris and passed that the Chairman get in touch with the Department of Human Resources and ask assistance from that Department in getting a cost estimate and the requirements for a holding cell that would be located in the Courthouse. After this information is available a decision will be made on assigning the office space in the Courthouse.

At 12:00 noon the Chairman announced that bids would be opened and read aloud for the purpose of rebuilding of a 1973 White Truck and body. The following bids were received:

There was a discussion concerning a rebuilt truck vs a new truck and the Board decided to advertise for a new truck with equipment to pick up sleeve containers rather than A-frame pick up. Neither of the above bids were accepted at this time.
