## APPROVAL OF MINUTES

The minutes of the December 20th meeting were approved as recorded upon motion by Commissioner Dew and seconded by Commissioner Marlowe with the following change - Page 624, Paragraph 1 - to award the audit for fiscal year 82/83 to Moore & Price, CPA., at a cost of \$110.00 per accountant's day.

# SHERIFF'S REPORT

Sheriff William G. Rhodes met with the Board to discuss the State Jail Inspector's Report and repairs necessary for the Law Enforcement Center.

He also requested that Deputies who have accumulated over thirty days vacation be allowed to either take their extra time off or be paid for the time. The County Administrator explained the County policy on vacation leave, which states that any vacation accumulated over thirty days is lost. The Board concurred with the Administrator to uphold the County policy. HAZARDOUS WASTE ORDINANCE

There was a discussion concerning the proposed Hazardous Waste Ordinance. The County Administrator advised the Board of the changes suggested by the State Crime and Public Safety Department.

Garland McCullen, Agriculture Extension Chairman, was present to advise the Board on behalf of the farmers in the area as to the effect the Ordinance would have on their disposal of pesticides.

Commissioner Dew requested that a public hearing be held before the adoption of the Ordinance. The County Administrator and County Attorney are to work together on the project to prepare the final draft of the Ordinance.

# SIGNATORY AUTHORITY

There was a discussion on the purchase of a facsimile signature stamp to be used for signing checks. There was a general concensus of the Board that a stamp should not be used for signing checks.

However, upon motion of Commissioner Dew and seconded by Commissioner Buffkin, a stamp is to be purchased for which to sign purchase orders issued by all departments. The stamp will signify the authorization of the County Administrator.

### RETIREMENT RESOLUTION

The following resolution was passed upon motion of Commissioner Buffkin and seconded by Commissioner Norris:

THE BOARD OF COUNTY COMMISSIONERS OF COLUMBUS COUNTY, NORTH CAROLINA, at a regular meeting on the 3rd day of January, 1983, adopted the following resolution with respect to the Local Government Retirement System:

WHEREAS, the County of Columbus, has been requested in the past to make voluntary contributions to the North Carolina Local Governmental Employees' Retirement System on behalf of present and newly hired employees of the said County; and

WHEREAS, the Board of County Commissioners are cognizant of the fact that they will, as a board, be requested in the future to contribute by resolution to the said retirement system on behalf of future employees who are eligible for past retirement credits;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF COLUMBUS COUNTY that they shall not presently or in the future make any voluntary contributions for any employees; and

BE IT FURTHER RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF COLUMBUS COUNTY that any county employee, past, present or future may contribute of his or her private funds, any amount that they so elect and which is permissible by the retirement system; and

BE IT FURTHER RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF COLUMBUS COUNTY that a copy of this resolution be forwarded to the North Carolina Department of the Treasurer, Local Governmental Retirement System Division.

Upon motion of Commissioner Marlowe and seconded by Commissioner Norris, the Board resumed their regular meeting.
