COLUMBUS COUNTY YOUTH TASK FORCE

Tommy Holmes, Mental Health Director, represented the Youth Task Force requesting approval of an In-School Suspension program with the budget totaling \$7,862.05 of unused funds in the County. No additional appropriation is being requested from the County.

A motion was made by Commissioner Buffkin, seconded by Commissioner Dew and passed unanimously to adopt the In-School Suspension program.

ASSOCIATION FOR RETARDED CHILDREN - SUMMER PROGRAM

Lois Smith, Association for Retarded Children, requested that the Board contribute \$5,000.00 for the Summer Program for Autistic and other handicapped children.

A motion was made by Commissioner Buffkin, seconded by Commissioner Dew and passed unanimously to amend the budget in the amount of \$5,000.00 from Contingencies (Item 10-999-0000) to ARC - Summer Handicapped Program (Item 10-690-9509). CITIZENS FOR TAX RATE REDUCTION

Robert Inman, Chairman of the Citizens for Tax Rate Reduction, acted as spokesperson for the concerned citizens of the County concerning the changing of Board Meeting times; one meeting per month to be held in the evening/night and one meeting per month to be held in the morning.

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed that the request be tabled and the Administrator is to research the request.

HEALTH DEPARTMENT - PRE-NATAL PHYSICIAN SERVICES

Steve Smith, Columbus County Health Department Health Director, requested the Board to initiate a contract with Dr. Covie Stanley for pre-natal physician services for approximately \$5,000.00 from March 1, 1983 and terminate on June 30, 1983, and subject for renewal at that time. The contract with Dr. Stanley will replace the contract with Dr. Samuel Wheatley as of the end of February, 1983. Dr. Wheatley has agreed to return to the county a pro-rated share of the funds that will pay Dr. Stanley until June 30, 1983.

A motion was made by Commissioner Dew, seconded by Commissioner Marlowe and passed unanimously to replace Dr. Samuel Wheatley with Dr. Covie Stanley for pre-natal physician services.

SOUTHEASTERN REGIONAL MENTAL HEALTH

The Administrator stated to the Board that he had been contacted by Don Stocks with Southeastern Regional Mental Health concerning the purchasing of one (1) acre of land on the Health Center Road to construct a home for mentally retarded children ("Willie M") under 18 years of age. The funds have been appropriated by the State for construction and will be funded by the state for operation.

A motion was made by Commissioner Norris, seconded by Commissioner Dew and passed unanimously to have Attorney James E. Hill, Jr., and the Administrator to investigate the possibility of recovering the property if state funding ceases.

- 9. East Lees' Voting Precinct will be using the Whiteville Chamber of Commerce Santa-Claus trailer for voting as the old precinct has been condemned.

10. Commissioner Lynwood Norris has been unanimously elected Chairman by the Cape Fear Council of Governments.
