# PUBLIC OFFICIALS CONFERENCE - EMERGENCY MANAGEMENT

The Emergency Management personnel were introduced to the Board by
Howard Stanley. The Officials gave an overview of the Emergency Management Program
for Columbus County. It was stated in the presentation that Columbus County Board
of Commissioners is to be commended for having a Plan prepared for handling
emergencies in the County before the emergency arises. They also commended Howard
Stanley, Emergency Management Coordinator, for Columbus County having done a good
job in handling the past emergencies in this county and in assisting other counties
when called upon to do so.

They urged the Board to support the Emergency Management Program and to be vocal to the media to make the public aware of this program. They stated that the State Office is available to assist counties in training for emergency preparedness. They also placed emphasis on the four phases of Comprehensive Emergency Management: Mitigation, preparedness, response and results. A slide presentation of a tornado in Lubock, Texas was shown which demonstrated how their Emergency Management Program responded to a disaster.

Mr. Stanley pointed out that he is available to the Towns as an advisor and to make recommendations in case of an emergency but not make decisions. He

stated the decision making within the Towns is with the Town Officials and at the County level, with the Board of Commissioners. The Emergency Operations Center is located at the Law Enforcement Center.
