WHEREAS, the Board of County Commissioners caused public notice of the public hearing to be given in accordance with law at least ten days prior to the date of the hearing; and

WHEREAS, the Board of Commissioners of Columbus County is now of the opinion and does hereby find and declare that the levy of said sales tax within Columbus County is both desirable and necessary to adequately finance the operation of the county and the cities and town herein;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Columbus County as follows:

Section 1. There is hereby imposed and levied within Columbus County the one-half percent (1/2%) supplemental local government sales and use tax authorized by Ratified Chapter 908 of the 1983 Session Laws, and codified as Article 40 of Chapter 105 of the General Statutes of North Carolina, effective July 21, 1983. The tax hereby imposed and levied shall apply to the same extent and be subject to the same limitations as are set forth in said Chapter 908.

Section 2. Collection of the tax by the North Carolina Secretary of Revenue, and liability therefor, shall begin and continue on and after the first day of November, 1983.

Section 3. The net proceeds of the tax levied herein shall be distributed by the Secretary of Revenue on a quarterly basis to Columbus County as prescribed by G.S. 105-486. The amount distributed to Columbus County shall be divided among the County and the municipalities herein in accordance with the method by which the one percent (1%) sales and use taxes levied in Columbus County pursuant to Article 39 of General Statutes Chapter 105 are distributed.

Section 4. This Resolution shall become effective upon its adoption and a certified copy hereof shall be forwarded to the North Carolina Secretary of Revenue.

RESOLUTION - ESTABLISH CAPITAL REVENUE FUND

A motion was made by Commissioner Dew, seconded by Commissioner Faulk and passed unanimously to adopt a resolution to establish a capital revenue fund for Columbus County Library as follows:

RESOLUTION

BE IT RESOLVED by the Board of County Commissioners of Columbus County, pursuant to G.S. 159.18, that there is hereby established a Capital Reserve Fund to aid in the long term financing of a capital project for the Columbus County Library.

Section 1. Funds accumulated in said capital reserve fund are intended to be used for the construction and expansion of the County Library's facilities.

Section 2. The Board of County Commissioners will make appropriations from this fund to finance capital projects, which are a multi-year program, to expand the Columbus County Library's facilities, with input from the Columbus County Board of Trustees.

Section 3. The fund will remain operational for a period, not to exceed ten (10) years or until a cumulative sum, not to exceed three hundred, fifty thousand dollars (\$350,000.00) has been accumulated for the expansion of the Columbus County Library's facilities.

Section 4. Sources of revenue for this fund will be donations from private citizens and special interest groups who wish to help improve and expand the Columbus County Library system; Columbus County Commissioners, if funds are available and needed; and State and federal aid, contingent on availability of grant funds. Also, interest earned on the reserved funds will be a source of revenue in accumulating the above stated amount.

Section 5. None of the above funds will be used for salaries or operating purposes and may only be removed from the capital reserve fund by action of the Board of County Commissioners to be transferred into a capital projects fund.
