ANVIL KNITWEAR PLANT ANNOUNCEMENT

The meeting was called to order by the Chairman and the invocation was given by Rector Robert Schriber, Grace Episcopal Church in Whiteville.

APPROVAL OF MINUTES

The minutes of the October 17th meeting were approved as recorded upon motion by Commissioner Norris, seconded by Commissioner Dew and passed unanimously.

Jack Ervin, Economic Development Director, announced that Anvil Knitwear had purchased the Fieldcrest Mills building to manufacture knit shirts. They are scheduled to begin operation January 3, 1983 and will employ approximately 100 persons immediately.

SENIOR CITIZEN ADVISORY COUNCIL

Several senior citizen advisory council members were present with Juanita Corbin acting as spokesperson for the group. They requested the Board appropriate \$2,000 to hire a director for the center for the remainder of 1983. Cathy Williamson presented the Board with 861 signatures in favor of participating and supporting the Senior Center.

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to appropriate funds for the Senior Center in the amount of \$2,000 to hire a director and amend the budget for these funds to be transferred from Contingencies (10-660-9999) to Senior Citizen Project (10-690-9512).

BUGET AMENDMENT - OUTSTANDING 1982-83 PURCHASE ORDERS

COUNCIL ON THE STATUS OF WOMEN

A motion was made by Commissioner Norris, seconded by Commissioner Faulk and passed unanimously to sign a letter of authorization to members of the Columbus County Council on the Status of Women to gather data on the incidence of spouse abuse in the county and adopt the following Resolution:

RESOLUTION

WHEREAS, the Columbus County Council on the Status of Women serves an important function for the Citizens of Columbus County; and

WHEREAS, the Columbus County Council on the Status of Women desires to perform a need assessment on spouse abuse in Columbus County; and

WHEREAS, it is desireable that such a study be performed.

NOW, THEREFORE, BE IT RESOLVED that a study of spouse abuse be performed by the Columbus County Council on the Status of Women; and

BE IT FURTHER RESOLVED that a report on spouse abuse be made to the Commissioners of Columbus County, when the study is completed.

RETIREMENT SYSTEM - CREDIT FOR OUT OF STATE SERVICE

A motion was made by Commissioner Faulk, seconded by Commissioner Norris and passed unanimously to adopt a Resolution that will allow employees with ten (10) years of membership service to purchase credit to any state territory or governmental subdivision of the U.S. as follows:

RESOLUTION

WHEREAS, the 1973 General Assembly amended the North Carolina Local Governmental Employees' Retirement System laws so as to permit agreements for providing certain benefits for employee member pursuant to Chapter 1310; and

WHEREAS, the governing body of this Unit realizes the desirability of providing its employees with the security and protection provided by said benefits; and

WHEREAS, Article 3 of Chapter 128 of the General Statutes of North Carolina provides that any employer governmental unit desiring to provide said benefits for its employee members must excute an agreement therefor with the Director of the North Carolina Local Governmental Employees' Retirement System:

NOW THEREFORE, BE IT RESOLVED BY THE Columbus County Board of Commissioners in regular session,

1. That the Columbus County Board of Commissioners hereby elects to secure said benefits for its employees in the North Carolina Local Governmental Employees' Retirement System.

- 2. That the Columbus County Board of Commissioners hereby agrees to comply with all provisions of the North Carolina Local Governmental Employees' Retirement System as defined in Article 3, Chapter 128 of the General Statutes of North Carolina, as amended, and to make such increased employer's contributions as the Local Governmental Employees' Retirement System may determine to be necessary in order to provide said benefits.
- 3. The Columbus County Board of Commissioners is hereby ordered and directed to execute an agreement with the Director of the North Carolina Local Governmental Employees' Retirement System to implement said benefits of Chapter 1310 of the Session Laws of 1973 (2nd Session, 1974).

Upon motion of Commissioner Faulk and seconded by Commissioner Norris, the above resolution was introduced for passage. The following voted in the affirmative: 4. The following number voted in the negative: 0.

AGREEMENT

In accordance with the provisions of Chapter 1310 of the Session Laws of 1973 (2nd Session, 1974) setting forth the conditions under which the rights to certain benefits might be made available to members of the North Carolina Local Governmental Employees' Retirement System, this AGREEMENT is hereby entered into between the Columbus County Board of Commissioners and the Director of said Retirement System.

In consideration of an increase of zero (0%) in the employer's contribution rate effective as of December 1, 1983, the North Carolina Governmental Employees' Retirement System hereby agrees to extend the privileges and rights of said benefits described in Chapter 1310 of the Session Laws of 1973 (2nd Session, 1974) to the employees of the Columbus County who are members of said System on and after the above effective date. This Agreement shall continue in effect from year to year with the understanding that the rate payable for said benefits may be modified as the System's Actuary may periodically determine.

Approval of the above was authorized by Columbus County Board of Commissioners at its meeting on November 7, 1983 and is recorded in the minutes of said Board.

COUNTY HISTORIAN - JOHN A. MCNEILL

A motion was made by Commissioner Faulk, seconded by Commissioner Norris and passed unanimously to adopt a Resolution to designate John A. McNeill as County Historian as follows:

WHEREAS, the designation of a County Historian is necessary to provide the leadership in gathering and compiling such data for the use of the county; and

WHEREAS, the County recognizes that having this information available in the County would be a public service to all citizens.

NOW, THEREFORE, BE IT RESOLVED that the Columbus County Commissioners recognizes John A. McNeill as a dedicated citizen of Columbus County and designates Mr. McNeill to be the official Historian of Columbus County.

The foregoing Resolution was unanimously adopted at this meeting of the Columbus County Commissioners and ordered by the Chairman that the Clerk permanently
