The meeting was called to order by the Chairman and the invocation was given by the Reverend John Paschal, Whiteville United Methodist Church.

## PUBLIC HEARING

At 10:00 A.M., the Chairman of the Board of Commissioners for the County of Columbus announced that the Board would proceed to hold a public hearing and would hear anyone who wished to be heard on the proposed issuance by the Columbus County Industrial Facilities and Polution Control Financing Authority of not exceeding \$2,600,000 aggregate principal amount of its industrial development revenue bonds to finance the acquisition of an existing industrial plant consisting of approximately 15 acres located on Health Center Road west of NC Highway 130 immediately outside of the City of Whiteville, in Columbus County, North Carolina the approximately 41,104 square foot building thereon and the machinery and equipment, which plant will be used for the cutting, sewing and warehousing of textiles. The Industrial Project is to be owned and operated by McGregor Corporation, a New York Corporation.

The Chairman stated that the Authority had adopted a resolution expressing its intention to issue industrial development revenue bonds and authorizing the execution and delivery of a memorandum of agreement pertaining to the financing of the Industrial Project for the Company.

The County Administrator/Clerk to the Board presented an affidavit of an office of the News Reporter showing publication in the News Reporter on November 7, 1983, a date at least 14 days prior hereto, of notice of the public hearing. The Chairman directed that the affidavit of publication be attached to an extract of minutes as Exhibit A.

The Chairman requested that the County Administrator/Clerk to the Board inquire elsewhere in and around the Commissioners' Board Room to determine whether there were any other persons who wished to speak at the public hearing. The County Administrator/Clerk to the Board returned after making such inquiry to report that no other persons who wished to speak at the public hearing were found.

The Public Hearing was left open for 45 minutes for any further comment. APPROVAL OF MINUTES

The minutes of the November 7th meeting were approved as recorded upon motion by Commissioner Norris, seconded by Commissioner Faulk and passed unanimously with the following change - Page 44, paragraph 1 - to award the bid to Kabco Corporation in the amount of \$85,495.00 for one 1984 White Sanitation truck complete with cab and compactor body.

## SENIOR CITIZEN REQUEST

Several Senior Citizens from the Advisory Council were present with Angie Robinson acting as spokesperson for the group. They requested the Board contact Dr. Dan Moore, President of Southeastern Community College to appoint a temporary director for the Senior Citizens Center. Also, they requested the Board tentatively approve county land for the building of a Senior Center.

A motion was made by Commissioner Dew, seconded by Commissioner Faulk and passed unanimously to authorize the Adiministrator meet with Dr. Dan Moore and request a temporary director for the Senior Citizens Center and tentatively appropriate county property, west of Whiteville, (former Red Cross trailer location) for the building of a Senior Citizens Center. Also, Commissioner Dew requested that Mr. Self and Dr. Moore prepare data on approximate costs to the County on the Center for the next twenty (20) years.

## RESOLUTION - INDUSTRIAL REVENUE BOND - ANVIL KNITWEAR

A motion was made by Commissioner Norris, seconded by Commissioner Buffkin and passed unanimously to declare the public hearing of the Industrial Revenue Bond closed and adopt the Resolution as follows:

RESOLUTION APPROVING THE ISSUANCE OF NOT EXCEEDING \$2,600,000 AGGREGATE PRINCIPAL AMOUNT OF INDUSTRIAL DEVELOPMENT REVENUE BONDS OF THE COLUMBUS COUNTY INDUSTRIAL FACILITIES AND POLLUTION CONTROL FINANCING AUTHORITY TO FINANCE AN INDUSTRIAL PROJECT FOR McGREGOR CORPORATION AND APPROVING THE INDUSTRIAL PROJECT.

WHEREAS, the Board of Commissioners for the County of Columbus (the "Board") has created a political subdivision and body corporate and politic of the State of North Carolina known as "The Columbus County Industrial Facilities and Pollution Control Financing Authority" (the "Authority"); and

WHEREAS, the Authority is authorized under the Industrial and Pollution Control Facilities Financing Act, Chapter 159C of the General Statutes of North Carolina, as amended (the "Act"), to issue industrial development revenue bonds for the purpose, among others, of paying all or any part of the cost of any industrial or pollution control project for industry; to acquire, construct, improve and equip any such project; and to make and execute financing agreements, security documents and other contracts and instruments necessary or convenient in the exercise of such powers; and

WHEREAS, the Authority has determined to issue not exceeding \$2,600,000 aggregate principal amount of its industrial development revenue bonds to pay all of the costs of the acquisition of an existing industrial plant consisting of approximately 15 acres located on Health Center Road west of N.C. Highway 130 immediately outside of the City of Whiteville, in Columbus County, North Carolina, the approximately 41,104 square foot building thereon and the machinery and equipment therein, and the construction of an approximately 40,000 square foot addition to the building and the acquisition and installation of additional machinery and equipment, which plant will be used for the cutting, sewing and warehousing of textiles (the "Industrial Project"), which Industrial Project is to be owned and operated by McGregor Corporation, a New York corporation (the "Company"); and

WHEREAS, the Authority intends to file an application for approval of the Industrial Project with the Secretary of the Department of Commerce (the "Department") as required by the Act; and

WHEREAS, the Department has, by regulation, provided that no application for approval of a proposed industrial project by the Department will be officially received until the governing body of the county from which the application is made has, by resolution after having held a public hearing, approved the issue of industrial development revenue bonds and approved the proposed industrial project and a certified copy of such resolution has been provided to the Department; and

WHEREAS, the Board, pursuant to public notice duly given, has held a public hearing on the proposed industrial development revenue bond issue and Industrial Project and has considered the comments of persons who requested to be heard; and

WHEREAS, the Board desires to approve the issuance of industrial development revenue bonds and the Industrial Project; NOW, THEREFORE,

BE IT RESOLVED by the Board as follows:

- (1) The issuance of not exceeding \$2,600,000 aggregate principal amount of industrial development revenue bonds of the Authority to finance the Industrial Project is hereby approved.
  - (2) The Industrial Project is hereby approved.

## RESOLUTION - AVERAGE WEEKLY MANUFACTURING WAGE

A motion was made by Commissioner Faulk, seconded by Commissioner Buffkin and passed unanimously to adopt the following Resolution:

RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE COUNTY OF COLUMBUS REQUESTING THE SECRETARY OF THE DEPARTMENT OF COMMERCE TO APPROVE A PROPOSED INDUSTRIAL PROJECT FOR McGREGOR CORPORATION NOTWITHSTANDING THAT McGREGOR CORPORATION WILL NOT PAY AN AVERAGE WEEKLY MANUFACTURING WAGE ABOVE THE AVERAGE WEEKLY MANUFACTURING WAGE PAID IN COLUMBUS COUNTY.

WHEREAS, the Columbus County Industrial Facilites and Pollution Control Financing Authority (the Authority") has agreed to issue its industrial development revenue bonds in an aggregate principal amount not exceeding \$2,600,000 to finance the acquisition of an existing industrial plant consisting of approximately 15 acres located on Health Center Road west of N.C. Highway 130 immediately outside the City of Whiteville, in Columbus County, North Carolina, the approximately 41,104 square foot building thereon and the machinery and equipment therein, and the construction of an approximately 40,000 square foot addition to the building and the acquisition and installation of additional machinery and equipment, which plant will be used for the cutting, sewing, and warehousing of textiles (the "Industrial Project"), and in accordance with the provisions of G.S. 159C-7 will file shortly with the Secretary of the Department of Commerce an application for the approval of the Industrial Project; and

WHEREAS, subparagraph (1)a of G.S. 159C-7 of the General Statutes of the State of North Carolina provides:

"The Secretary [of the Department of Commerce] shall not approve any proposed project unless he shall make all of the following, applicable findings:

(1) In the case of a proposed industrial project,
(a) That the operator of the proposed project pays, or has agreed to pay thereafter, an average weekly manufacturing wage
(i) which is above the average weekly manufacturing wage paid in the county, or (ii) which is not less than ten percent (10%) above the average weekly manufacturing wage paid in the State \* \* \*."

and

WHEREAS, G. S. 159C-7 also provides that

"In any case where the Secretary shall make all of the required findings respecting a proposed industrial project except that prescribed in subparagraph (1) a of this section, the Secretary may, in his discretion, approve the proposed project if he shall have received (i) a resolution of the governing body of the county requesting that the proposed project be approved notwithstanding that the operator will not pay an average weekly manufacturing wage above the average weekly manufacturing wage in the county and (ii) a letter from an appropriate State official, selected by the Secretary, to the effect that unemployment in the county is especially severe."

and

WHEREAS, McGregor Corporation (the "Company") cannot represent that the Company expects to pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in Columbus County; and

WHEREAS, the Company has represented that the Industrial Project will eventually create employment for approximately 300 persons in Columbus County and the surrounding area; and

WHEREAS, the Board of Commissioners for the County of Columbus (the "Board") had determined to request that the Secretary of the Department of Commerce approve the

Industrial Project notwithstanding that the Company will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in Columbus County; NOW, THEREFORE,

BE IT RESOLVED by the Board as follows:

- (1) Because unemployment in Columbus County is, in its opinion, especially severe, the Board does hereby request that the Secretary of the Department of Commerce approve the Industrial Project pursuant to G.S. 159C-7, notwithstanding that the Company will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in Columbus County.
- (2) The County Administrator/Clerk to the Board is directed to file a certified copy of this resolution with the Department of Commerce.
  - (3) This resolution shall take effect immediately upon its passage.
