The meeting was called to order by the Chairman and the invocation was given by Father Richardson, Sacred Heart Catholic Church.

APPROVAL OF MINUTES

The minutes of the April 16, and April 17 meetings were approved as recorded upon motion by Commissioner Hinson, seconded by Commissioner Faulk and passed unanimously.

LUMBER RIVER DEDICATION

Dempsey Herring, Recreation Director, invited the Board to attend the official dedication of the Lumber River Recreation Trail in Fair Bluff on May 16, 1984, at 9:30 A.M.

DIVISION OF FOREST RESOURCES - PRESENTATION

Laird Davison and Melvin Brown, N. C. Forestry Representatives, requested the Board to support a program that would provide a quarter of a million dollars in forestry management in Columbus County with operating cost of approximately \$20,000 to the county annually. Mr. Davison reported he would need an answer by June 8 when the General Assembly convenes.

A motion was made by Commissioner Dew, seconded by Commissioner Hinson and passed unanimously to write a letter to the N. C. Forestry Service supporting the program with no firm committment until after budget time.

BUCKHEAD RESCUE SQUAD - ARTICLES OF INCORPORATION

Howard Stanley, Emergency Management Coordinator, requested the Board to allow the Buckhead Rescue Squad, Bolton, N.C. to operate in Columbus County and accept their Articles of Incorporation.

A motion was made by Commissioner Dew, seconded by Commissioner Faulk and passed unanimously to allow the Buckhead Rescue Squad to operate in Columbus County and accept the Articles of Incorporation.

INDIRECT COST PLAN - DAVID GRIFFITH & ASSOCIATES

A motion was made by Commissioner Dew, seconded by Commissioner Faulk and passed unanimously to continue the contract with David M. Griffith & Associates to prepare our Indirect Cost Allocation at an annual cost of \$7,000 and authorize the Chairman sign the necessary documents.
