BOARD OF ELECTIONS MOVED TO MILLER BUILDING AND BOARD OF ELECTIONS BUILDING TO BE RENOVATED FOR SENIOR CENTER

Chairman Norris introduced a proposal to the Board on the Board of Elections being moved to the Miller Building and renovating the Board of Elections Building for a Senior Center which will cost the County approximately \$65,000. facility as previously bid.

RESOLUTION REQUESTING "PORK BARREL" FUNDS FOR SENIOR CENTER FURNITURE

A motion was made by Commissioner Dew, seconded by Commissioner Faulk and passed unanimously to adopt the following Resolution requesting Senator R. C. Soles, Jr. to request allocations from the "Pork Barrel" fund to purchase furniture for the Senior Center:

WHEREAS, COLUMBUS COUNTY is renovating a facility which is to be designated the Columbus County Senior Center; and

WHEREAS, funds have been appropriated for the renovation and addition to the facility to provide ample room and an esthetically pleasing environment, but no funding has been appropriated for the provision of furniture and fixtures in the facility;

WHEREAS, it would be desireable to provide the Center with furniture and kitchen appliances.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Columbus County that R. C. Soles, Jr., State Senator, is hereby respectfully requested to designate a special appropriation to the Senior Citizen Center to be used for furnishings.
