DESIGNATION OF AGENT FOR FEDERAL & STATE FUNDING - DAMAGES INCURRED BY HURRICANE

A motion was made by Commissioner Dew, seconded by Commissioner Buffkin and passed unanimously to designate the County Administrator, Richard B. Self, as Columbus County's agent to handle all disaster funding received due to Hurricane Diana. Resolution is as follows:

R E S O L U T I O N

BE IT RESOLVED BY Columbus County Commissioners of Columbus County that Richard B. Self, County Administrator or Edwin Harris, Governor's Authorized Representative is hereby authorized to execute for and in behalf of Columbus County, a public entity established under the laws of the State of North Carolina, this application and to file it in the appropriate State office for the purpose of obtaining certain Federal financial assistance under the Disaster Relief Act (Public Law 288, 93rd Congress) or otherwise available from the President's Disaster Relief Fund.

THAT Columbus County, a public entity established under the laws of the State of North Carolina, hereby authorizes its agent to provide to the State and to the Federal Emergency Management Agency (FEMA) for all matters pertaining to such Federal disaster assistance the assurances and agreements printed on the reverse side hereof.

LETTER OF APPRECIATION TO CRAVEN COUNTY

Commissioner Dew requested the Administrator write a letter of appreciation to Craven County for offering their resources to help Columbus County due to damages received from Hurricane Diana.

SIGNATURES ON TAX SUPERVISOR/COLLECTOR'S BOND

The Administrator requested signatures from the Board and approval of a \$50,000 bond on Ralph Jolly, Tax Supervisor/Collector. The request was granted.

REPORT ON GOVERNOR HUNT'S VISIT TO COLUMBUS COUNTY

The Chairman reported on Governor Hunt's visit to Columbus County on Wednesday, September 26, 1984, to view hurricane damages. Governor Hunt stated that total damages to crops probably exceeds all other damages. He will be seeking help for low interest loans for the farmers and will advise the County of his findings when he returns to Raleigh.
