The meeting was called to order by the Chairman and the invocation was given by Mr. Ed Worley.

APPROVAL OF MINUTES

A motion was made by Commissioner Hinson, seconded by Commissioner Faulk and passed unanimously to approve the minutes of the September 17, September 20, and September 27, 1984 meetings with an amendment to Book 19, page 183, paragraph 8, to delete the ending phrase "at 12:00 midnight."

BUDGET AMENDMENT - SHERIFF'S DEPARTMENT

A motion was made by Commissioner Faulk, seconded by Commissioner Dew and passed unanimously to amend the Sheriff's Department budget to replace an auto that burned as follows: Accept Miscellaneous Revenue (insurance claims) 10-335-00 in the amount of \$10,080.00, to be expended in Capital Outlay - Auto 10-510-74.

SOLID WASTE LABORER EMPLOYED

A motion was made by Commissioner Hinson, seconded by Commissioner Dew and passed unanimously to employ Calvin Jenrette, Jr. as a Solid Waste Laborer to replace Charles Powell, effective October 2, 1984, at the pay scale of 54-1, salary \$7,836.00 yearly.

LETTERS FROM GOVERNOR JIM HUNT ASSISTING COLUMBUS COUNTY FARMERS DUE TO HURRICANE DIANA

The Administrator read a letter from Governor Jim Hunt requesting the President declare Columbus County a disaster area and requested disaster assistance.

A second letter was read from Governor Hunt stating that Columbus County has been declared eligible for Farmers' Home Administration disaster loan assistance because of adverse weather conditions due to Hurricane Diana. The deadline for requesting loans for agricultural damages is May 31, 1985.

The Chairman requested the news media publish the letters in the newspapers in order for Columbus County farmers to be aware of the disaster assistance.

TAX RELEASES


MEETING ADJOURNED
