PUBLIC HEARING - COMMUNITY DEVELOPMENT BLOCK GRANT APPROVAL

At 10:35 A.M., A Public Hearing was called to order by the Chairman. He stated the purpose of the hearing was to receive comments on the approval of a \$300,000.00 Community Development Block Grant to help finance a new produce marketing business in Columbus County.

The Chairman allowed any person present who wished to be heard express their concerns or ask questions.

All comments were favorable.

Upon motion by Commissioner Norris, seconded by Commissioner Faulk and passed unanimously, the public hearing adjourned.

COMMUNITY DEVELOPMENT BLOCK GRANT APPROVED - FOUR SEASONS PRODUCE

A motion was made by Commissioner Dew, seconded by Commissioner Worley and passed unanimously to approve the County Attorney and County Administrator execute the necessary papers for the submission of this grant if the proposal is in compliance as outlined at the Public Hearing, this date, including State and Federal guidelines not to exceed the sum of \$300,000.00. Resolution is as follows:

RESOLUTION

WHEREAS, Small Cities Community Development Block Grants are authorized by the Housing and Community Development Act of 1974, as amended.

WHEREAS, said program is administered by the North Carolina Department of Natural Resources and Community Development.

WHEREAS, Columbus County has prepared an application in accordance with said regulations at the request of Four Seasons Produce, Inc., in the amount of \$297,600.00, said funds to be utilized for a loan to finance plant, equipment and other current assets for a farm produce marketing facility to be situated within Columbus County.

WHEREAS, the County Board finds that said development will substantially expand employment needed to support public services and provide needed services and

expand the area's attractiveness for future development.

WHEREAS, the County is authorized to make this loan under authority

granted under North Carolina G.S. 153A-376.

NOW, THEREFORE, Be It Resolved by the Board of Commissioners of Columbus

County, that:

1. The Chairman is authorized to file an application for a grant from North Carolina Department of Natural Resources and Community Development for a total of \$297,600.00. Said funds in the amount of \$297,600.00 to be applied as principal by Four Seasons Produce, Inc. for the purpose of financing the acquisition of plant, equipment and current assets in conjunction with the establishment of its new produce marketing facilities to be situated within Columbus County.

- 2. The County of Columbus hereby assures and certifies that to the best of its ability it will comply with those federal laws and regulations set forth in Part IV Assurances, which are attached and hereby made a part of this Resolution.
- 3. The County Administrator is authorized on behalf of Columbus County to execute legally binding loan agreement with Four Seasons Produce, Inc. to provide said loan in the principal amount of \$297,600.00 to implement the terms and conditions of the County's application to the North Carolina Department of Natural Resources and Community Development.

RESOLUTION - INCREASE NUMBER OF CAMPERS AT LAKE WACCAMAW

A motion was made by Commissioner Norris, seconded by Commissioner Faulk and passed unanimously to draft a Resolution to Mr. Thomas Rhodes, Secretary of

Natural Resources and Community Development, to intervene and change a state policy

that prevents groups larger than 25 people from camping at Lake Waccamaw State Park.

Resolution is as follows:

RESOLUTION

WHEREAS, Lake Waccamaw State Park is located in the County of Columbus and

provides passive recreation to the citizens of Columbus County, the State of North

Carolina and the Nation; and

WHERAS, Columbus County took the initiative and constructed the Lake

Waccamaw State Park for the State of North Carolina; and

WHEREAS, Columbus County did appropriate and expended THIRTY THOUSAND DOLLARS (\$30,000.00) to assist the State in this endeavor; and

WHEREAS, Representative Richard Wright provided an allocation of ONE HUNDRED THOUSAND DOLLARS (\$100,000.00) for construction of a road to the facility; and

WHEREAS, the Boy Scouts of America, Troop 513 of Whiteville, North Carolina, did require permission to the Park for a supervised camp-out and were denied. Further, they were informed that a limit of twenty-five (25) persons were allowed to utilize the camping facilities.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Columbus County object to the arbitrary limit of twenty-five (25) campers and feel that the Boy Scouts of America should be allowed to utilize the Lake Waccamaw State Park for supervised camping.

BE IT, FURTHER, RESOLVED that a copy of this Resolution be sent to James Martin, Governor, Thomas Rhodes, Secretary of Natural Resources and Community Development, and to Troop 513, of the Boy Scouts of America.
