RESOLUTION - COLUMBUS COUNTY DIALYSIS CENTER

RESOLUTION

WHEREAS, the Board of Commissioners of Columbus County has been committed to providing transportation for patients of Columbus County to Wilmington to receive life sustaining dialysis treatment; and

WHEREAS, the Board of Commissioners is aware of a Certificate of Need application for establishment of a satellite dialysis unit in Whiteville for these patients; and

WHEREAS, the establishment of that facility would likely eliminate the need for transportation services now provided by Columbus County, but also, more importanly, provide more ready access for residents of Columbus County who have need for life sustaining dialysis; and

WHEREAS, the Board of Commissioners is aware of and supports the Certificate of Need application for a dialysis facility in Whiteville, allowing the patients from Columbus County to continue to receive treatments from the same doctors and medical staff they have been using in Wilmington, but at a new, more accessible site in Whiteville.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners supports the application of Southeastern Dialysis Center, Incorporated for an outpatient dialysis facility in Whiteville to improve the provision of medical care and at the same time reduce county expenditures for transportation.
