APPROVAL OF MINUTES

The minutes of the January 20, 1986 meeting were approved as recorded, upon motion by Commissioner Norris, seconded by Commissioner Worley and passed unanimously.

CITY SCHOOLS CAPITAL OUTLAY FUNDS REQUEST

Dr. Jerry Paschal, City Schools Superintendent, addressed the Board concerning the status of City Schools Capital Outlay funds for fiscal year 1985-86 and requested consideration on additional funding when Revenue Sharing is being dispersed. Dr. Paschal also thanked the Board for their past support and consideration.

RESOLUTION - FARM FORECLOSURES

Ms. Jeanette King and Ms. Bertie King from Brunswick County addressed the Board on the plight of farmers in the area of farm foreclosure. They stated Brunswick County has adopted a Resolution opposing farm foreclosures and requested Columbus County adopt a Resolution in opposition.

A motion was made by Commissioner Buffkin, seconded by Commissioner Norris and passed unanimously to adopt a Resolution in opposition of all foreclosures.

RESOLUTION

WHEREAS, many business concerns; including agriculture are facing uncertain economic times; and

WHEREAS, due to the strong U.S. dollar in the world market, increased imports, the long-term effects of high interest rates on old loans, and the cumulative effect of inflation; and

WHEREAS, the profitability of farming has decreased drastically with the increased restrictions on tobacco marketing and the increase in assessments; the decrease in profitability on U.S. made products when competing with imports; and

WHEREAS, decreased productivity and income has a multiplier effect on the economy, that when the farm income is down, it has a direct impact on the income of merchants and thus on manufacturers in our county, our state and our nation; and WHEREAS, the final effect of the economy is the closing of businesses, the merger of businesses, and the foreclosure of businesses and the liquidation of farms.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Columbus County requests lending institutions, the state government and the federal government refrain from pursuing foreclosures for the calendar year 1986.

BE IT FURTHER RESOLVED, that the lending institutions and various governmental agencies work with the financially depressed accounts and assist in reorganizing the debts. In this way, the lenders stand a better chance of recovering the monies loaned and the debtors stand a better chance of remaining viable in their business concerns.
