# COLUMBUS COUNTY FIRE AND RESCUE ASSOCIATION - REQUEST FOR ARSON INVESTIGATOR

The Administrator read aloud a Resolution adopted by the Fire and Rescue Association in opposition of a Fire Marshall and requested the Sheriff designate and train one (1) deputy as an Arson Investigator. Jake Jones, Assistant to the Chairman of the Committee of 100, has polled the Committee of 100 Board Members and they concurred to appropriate funds up to the amount of \$2,000 toward the training of an Arson Investigator.

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to accept the funds from the Committee of 100 toward the training of one (1) deputy as Arson Investigator with the stipulation that the person trained for this position remain in the employment of Columbus County for at least one (1) year after the training period.

# RESOLUTION - AGRICULTURE EXTENSION LOSS OF FUNDING

A motion was made by Commissioner Worley, seconded by Commissioner Norris and passed unanimously to adopt a Resolution to oppose proposed federal budget cuts that could affect the operation of the Agriculture Extension Agency.

### RESOLUTION

WHEREAS, Columbus County recognizes the need for the Federal Government to balance their expenditures with the available revenues; and

WHEREAS, it is recognized that many hardships will be faced by the nation as a whole and in some areas, deleted programs in Columbus County; and

WHEREAS, even though defense is recognized as an area to be protected and nurtured, even at the expense of many favorite programs; and

WHEREAS, the plight of the farmer who has suffered more heavily than any other sector of our economy through world market prices, high interest rates, foreclosures, increased prices for fertilizers, herbicides and equipment without the corresponding increase in revenue; and

WHEREAS, the funding level for the Cooperative Extension Service is scheduled to be reduced by 59% in the Fiscal Year 1987 Federal budget; that this will mean a reduction in the North Carolina budget of 54% which will be passed on to the counties through reduced staff, reduced funding, and request for increased local funding.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Columbus

County opposes the reduction of funding in the area of Agriculture Extension Services

BE IT FURTHER RESOLVED, that the need and support of the farmer is needed from all levels of government, that a reduction in this area could force more farmers to lose their farms and could seriously jeopardize the trend to efficient farm management which has been fostered by Agriculture Extension Service.
