The meeting was called to order by the Chairperson and the invocation was given by Rev. L. C. Joyner, Whiteville First Pentecostal Holiness Church.

APPROVAL OF MINUTES

Upon motion by Commissioner Norris, seconded by Commissioner Buffkin and passed unanimously, the minutes of the March 17, 1986 meeting were approved as recorded.

SOLID WASTE - AWARD OF BID FOR CAB & CHASSIS

The Administrator presented six (6) bids for a Chassis and Cab Truck for the Solid Waste Department as follows:

A motion was made by Commissioner Norris, seconded by Commissioner Worley and passed to award the contract to the lowest bidder, Fair Bluff Motors, in the amount of \$8,998.00. All bid deposits will be returned to unsuccessful bidders. Three Commissioners voted for and one did not vote.

SOLID WASTE - EMPLOYEES' OVERTIME

A motion was made by Commissioner Norris, seconded by Commissioner Buffkin and passed unanimously to give compensatory time to all employees who have accumulated overtime hours.

COUNTY-WIDE WATER PROJECT

The Chairperson stated there has been some confusion concerning the county-wide water project and requested Mr. Jack Ervin, Economic Development Director, clarify any questions that the public might have.

In response to the Petition presented to the Board, Mr. Ervin clarified (1) voluntary hook-up to the water system only; (2) loans and grants from FmHA must be approved; (3) county-wide bond issue must pass; and (4) 86% voluntary hook-up needed. If any of the above is not met, the system would not proceed.

CITY OF WHITEVILLE - RELEASE OF REVERSION CLAUSE ON LAND

The Administrator advised the Board that the City of Whiteville is requesting the County release the State of North Carolina from the Reversion on one (1) acre tract of land so that they could in turn lease the tract to the City

for a well.

A motion was made by Commissioner Buffkin, seconded by Commissioner Norris and passed unanimously to approve the City's request in accordance with the Deed of Release, recorded in the Register of Deed's Office, April 15, 1986, Book 373, Page 366, 367 and 368.

HEALTH DEPARTMENT - HOME HEALTH COMPUTER BIDS

The Administrator presented three (3) computer bids for Home Health, including software, installation and debugging as follows:

The Chairperson requested Walter Batten, Solid Waste Supervisor, take an inventory of all tools owned by the County Solid Waste Department and present to the Board within 30 days.
