The meeting was called to order by the Chairperson and the invocation was given by Reverend Elbert Waddell, Friendly Baptist Church.

The Chairperson announced that the meeting would recess to the District Courtroom of the Columbus County Courthouse due to the number of persons in attendance.

APPROVAL OF MINUTES

Upon motion by Commissioner Norris, seconded by Commissioner Worley and passed unanimously, the minutes of the June 2, 1986 meetings (10:00 A.M. and 7:00 P.M.) were approved as recorded.

FOX HUNTING AND TRAPPING

The Chairperson announced that the Board would like input considering adopting a Fox Season in Columbus County and requested each person wishing to speak to be recognized by raising their hand and stating their name. The following persons addressed the Board on the issue: Ervin Long, Junior Duncan, Harold Jacobs, Wayne Cartrette, Clyde Hilbourn, and Harry Ward.

The Board reached a general concensus to make a decision on a Fox Season at a later date.

MEDICAL ALERT TRANSPORT SERVICES, INC.

Ervin Jacobs, Medical Alert Transport Services, Inc., President, reported on services rendered by his Organization for the past thirty (30) days and stated that there is no conflict between their service and the Buckhead Rescue Squad.

Mr. Howard Stanley, Emergency Management Coordinator, commended Medical Alert on the good services they are providing for the County and considers them as being an asset in their profession.

SOLID WASTE - ODELL SMITH PRESENTATION

Mr. Odell Smith and Mr. John Holbcomb presented a petition to the Board with signatures of fifty-five (55) property owners and/or residents of the surrounding landfill area desiring to have the Columbus County Landfill closed allegedly due to: "water pollution, sickness, hazardous waste, rats and littering."

The group in attendance requested an answer on their problem by the next

Board meeting.

COLUMBUS COUNTY FARM BUREAU REQUEST FOR VARIANCE IN PROPERTY SET-BACK

A motion was made by Commissioner Norris, seconded by Commissioner Worley and passed unanimously to write a letter to the Whiteville Board of Adjustments indicating approval for a variance in the set back requirement for the Columbus County Farm Bureau property on Smith Street adjoining property of Columbus County.

BOLTON VOLUNTEER FIRE DEPARTMENT - REQUEST FOR RADIO

RESOLUTION - OUT-OF-STATE USE OF COUNTY SOCIAL PROGRAMS

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to adopt a Resolution in opposition of out-of-state of County Social Programs as follows:

RESOLUTION

WHEREAS, the State and Federal Governments mandate certain social programs for the County to perform; and

WHEREAS, if a person from another state applies in Columbus County for assistance from Medicaid or State/County Special Assistance, Columbus County must take and process their application. If they meet the eligibility requirements regardless of their state of origin, then approval must be given; and

WHEREAS, due to the proximity of the rest homes at Lake Waccamaw and at Tabor City, Columbus County is having a number of South Carolina residents apply for benefits under Columbus County; and

WHEREAS, residents from other states will be filling beds that could be used for Columbus County residents, thereby forcing Columbus County residents to seek beds in other counties for this needed service; and

WHEREAS, if residents of other counties are placed in rest homes in Columbus County, those counties pay the cost, but if the patients are from another state, Columbus County must pay the cost, even if the client has never paid taxes or resided previously in the County.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Columbus County request the General Assembly to enact legislation which will shift this unfair financial burden not only on Columbus County, but all counties which border other states.
