The Chairperson called the meeting to order and Commissioner Samuel G. Koonce gave the invocation.

APPROVAL OF MINUTES

The minutes of the July 21, 1986 meeting were approved as recorded upon motion by Commissioner Norris, seconded by Commissioner Worley and passed unanimously.

RESOLUTION - OPPOSING INVENTORY TAX

A motion was made by Commissioner Dew, seconded by Commissioner Worley and passed unanimously to adopt the following Resolution in opposition of inventory tax:

RESOLUTION

WHEREAS, the North Carolina General Assembly enacted North Carolina General Statute 105-317.1 entitled APPRAISAL OF PERSONAL PROPERTY: ELEMENTS TO BE CONSIDERED, which requires that all inventories be listed at market value; and

WHEREAS, the North Carolina General Assembly has mandated that counties comply with the Statutes of North Carolina and enforce them to the best of their ability whether or not the Board of County Commissioners agrees or supports the Statute; and

WHEREAS, the Board of County Commissioners of Columbus County are required to enforce the laws, rules and regulations passed by the North Carolina General Assembly whether the laws deal with listing taxes or the payment of Social Service Programs; and

WHEREAS, the Board of County Commissioners of Columbus County does not control the actions of the North Carolina General Assembly or the elected Representatives from Columbus and other counties; and

WHEREAS, James Martin, Governor of North Carolina, has stated his support for the abolishment of the Inventory Tax but has not received the support of the North Carolina General Assembly; and

WHEREAS, the Board of Commissioners of Columbus County recognizes that the Inventory Tax is an unfair tax and that it creates a hardship on the businesses and industries in Columbus County; but recognizes that the Commissioners are powerless to abate the tax; and

WHEREAS, the General Assembly has exercised its power under the Constitution of North Carolina, Article V. Section 2, to levy additional taxes and to abolish the Personal Household Tax.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS OF COLUMBUS COUNTY that they oppose the Inventory Tax and request the General Assembly support the Governor in his efforts to abolish the tax and replace any lost revenue to the counties from other State revenues.

BE IT FURTHER RESOLVED, that the revenues which would replace this tax be indexed to increase each year based upon a reasonable standard.

BE IT FURTHER RESOLVED, that the citizens of Columbus County are called upon to contact their elected Representative and Senator to support this RESOLUTION with their votes and influence with the North Carolina General Assembly.

COUNTY WIDE WATER SYSTEM BOND ISSUE
