The Honorable Columbus County Board of Commissioners met in their said office at 9:00 A.M., October 6, 1986, it being the first Monday. MEMBERS OF THE BOARD PRESENT: Caletta Faulk, Chairperson Ed Worley, Vice Chairman Junior Dew Lynwood Norris Samuel G. Koonce James E. Hill, Jr., Attorney The meeting was called to order by the Chairperson.

PUBLIC HEARING - COLUMBUS COUNTY WATER BOND

The Chairperson announced that this was the date and hour fixed by the Board of Commissioners for the public hearing upon the order entitled:

"ORDER AUTHORIZING \$17,000,000 WATER BONDS"

and that the Board would immediately hear any and all citizens and taxpayers who might desire to be heard on the questions of the validity of any of such order of the advisability of issuing said bonds.

No citizen or taxpayer of the County appeared, either in person or by attorney, to be heard on said questions, and the Clerk to the Board of Commissioners announced that no statement in writing signed by any citizen or taxpayer had been presented.

PUBLIC HEARING CLOSED

Upon motion by Commissioner Norris, seconded by Commissioner Dew and passed unanimously, the Public Hearing was closed.

Thereupon, upon motion of Commissioner Koonce, seconded by Commissioner Norris, the order introduced and passed on first reading on September 15, 1986, entitled: "ORDER AUTHORIZING \$17,000,000 WATER BONDS", was read a second time by title and placed upon its adoption. The vote upon the adoption of said order was:

The Chairperson then announced that the order entitled: "ORDER AUTHORIZ-ING \$17,000,000 WATER BONDS" had been adopted.

The Clerk to the Board of Commissioners was thereupon directed to

publish said order in the THE NEWS REPORTER once, and to publish at the foot of

said order the appended note as required by The Local Government Bond Act, as amended.

Thereupon Commissioner Norris introduced the following resolution which was read:

RESOLUTION CALLING A SPECIAL BOND REFERENDUM

BE IT RESOLVED by the Board of Commissioners for the County of Columbus:

Section 1. A special bond referendum is hereby called to be held in the County of Columbus on Tuesday, December 16, 1986, between 6:30 A.M. and 7:30 P.M., at which there shall be submitted to the qualified voters of the County of Columbus the question set forth in the Notice of Special Bond Referendum included in Section 3 of this resolution.

Section 2. For said referendum, (i) the regular registration books for elections in Columbus County shall be used, and the registration books, process or records shall be open for the registration of voters and for public inspection in the manner, under the conditions and at the times and places set forth in the Notice of Special Bond Referendum hereinafter provided for (ii) the registrars, Judges, sepcial registration commissioners and other officers of elections appointed by the Columbus County Board of Elections shall be the election officers for such referendum, and (iii) the precincts and voting places shall be those fixed by said County Board of Elections as provided in said Notice of Special Bond Referendum, subject to change as provided by law.

Section 3. The Clerk to the Board of Commissioners shall cause a notice to be published in <u>The News Reporter</u> once at least fourteen days before November 17, 1986 (being the last day on which persons may register for said referendum except as otherwise provided in said notice set forth in this Section) and once again not less than seven days before such day, such notice to read substantially as follows:

NOTICE OF SPECIAL BOND REFERENDUM to be held in the COUNTY OF COLUMBUS, NORTH CAROLINA on December 16, 1986

A special bond referendum will be held on Tuesday, December 16, 1986, between 6:30 A.M. and 7:30 P.M., at which there will be submitted to the qualified voters of the County of Columbus the following question:

> Shall the order adopted on October 6, 1986, authorizing not exceeding \$17,000,000 Water Bonds for the purpose of providing funds, with any other available funds, for constructing a water system for said County, including, but not limited to, supply and distribution facilities, and acquiring any necessary land, rights-of-way and equipment, and authorizing the levy of taxes in an amount sufficient to pay the principal of and the interest on said bonds, be approved?

The question hereinabove set forth contains a statement of the purpose

for which the bonds are authorized by the order referred to in such question.

If said bonds are issued taxes in an amount sufficient to pay the principal and interest thereof will be levied upon all taxable property in the County of Columbus.

For said referendum the regular registration books for elections in the County of Columbus will be used and the registration books, process or records will be open for the registration of qualified persons and the acceptance of registration applications at (i) the office of the Columbus County Board of Elections, 304 Jefferson Street, Whiteville, Nrth Carolina 28472, from Monday to Friday, inclusive, of each week, between the hours of 9:00 A.M. and 5:00 P.M., (ii) any public library in Columbus County during normal business hours, and (iii) any office of the Division of Motor Vehicles located in the State, when applying for, renewing or correcting their driver licenses. Registration applications will also be accepted by and qualified persons may also register with the registrars and judges of election for the several precincts in the County by appointment. The telephone number of the County Board of Elections is (919) 642-5700.

In addition, registration applications will be accepted by and qualified persons may register with the special registration commissioners designated by the Columbus County Board of Elections at such times and places as may be announced by the Columbus County Board of Elections.

Furthermore, certain persons in the armed forces and their spouses, certain veterans, certain civilians working with the armed forces and members of the Peace Corps may register by mail at any time prior to said referendum in the manner provided in Article 21 of Chapter 163 of the General Statutes of North Carolina and in person at any time, including the day of said referendum.

Those residents of the County who have not voted in either of one of the two most recent successive presidential elections or in any other election conducted in the period between said two elections will not be considered to be registered under Columbus County's permanent registration system.

Those residents of the County who are presently registered under Columbus County's permanent registration system and who have not changed residence from one precinct to another within the County since their registration will be permitted to vote in said referendum, provided that removal from one precinct to another shall not deprive any person of the right to vote in the precinct from which he has removed until 30 days after his removal and, further, that any person who has changed residence from one precinct to another more than 30 days prior to the special bond referendum may obtain a certificate of removal and record a change of address on the date of the referendum and vote in the office of the Columbus County Board of Elections mentioned above or at such other location as specified by the Columbus County Board of Elections.

The last day for new registration for those not now registered under Columbus County's permanent registration system is Monday, November 17, 1986.

The last day on which registered voters who have changed residence from

one precinct to another may transfer registration is Monday, November 17, 1986.

Any qualified voter of the County who is qualified to vote by absentee

ballot in said special bond referendum may apply to the Columbus County Board of

Elections for an absentee ballot. Any qualified voter who is qualified to vote by

military absentee ballot pursuant to Section 163-245 of the General Statutes of

North Carolina may also apply for an absentee ballot as provided by Section

163-247 of the General Statutes of North Carolina.

Persons who are not certain whether they are registered to vote or qualified to vote by absentee ballot should contact the Columbus County Board of Elections at the office of said Board mentioned above.

The registration books will be open to public inspection by any registered voter of the County during normal business hours, prior to the closing of the registration books, at said office of the Columbus County Board of Elections, and such days are challenge days.

The registrars, judges and other officers of elections appointed by the Columbus County Board of Elections will serve as the election officers for said referendum.

RESOLUTION - SOUTHEASTERN FARMERS' MARKET

RESOLUTION

WHEREAS, Columbus County recognizes the need for additonal sources of income for our farmers; and

WHEREAS, it is recognized that many hardships are faced by Columbus County farmers; and

WHEREAS, Columbus County has ideal soils, climate, location, and interest for vegetable production; and

WHEREAS, the plight of the farmer who has suffered more heavily than any other single sector of our economy through world market prices, high interest rates, foreclosures, increased prices for fertilizers, herbicides and equipment without the corresponding increase in revenue.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Columbus County recommends locating the Southeastern Farmers' Market in/or close proximity to Columbus County. Funding for such a market in Southeastern North Carolina has been appropriated by the General Assembly of North Carolina.

needed for all levels of government, and that vegetable marketing is a good means of providing alternatives for farmers which have been very dependent upon tobacco in the past.

RESOLUTION - GSX SERVICES

A motion was made by Commissioner Worley, seconded by Commissioner Norris and passed unanimously to adopt the following Resolution:

RESOLUTION

WHEREAS, the Board previously, at a meeting held on January 20, 1986, adopted a Resolution in opposition to the location of this hazardous waste facility and further resolved that the Columbus County Board of Commissioners requested a moratorium on all hazardous waste treatment facilities in the state; and

WHEREAS, since the adoption of the previous Resolution it has now been learned that the GSX facility in its application for approval has requested to be allowed the maximum allowable waste discharge into the Lumber River for every conceivable chemical and other hazardous waste; and

WHEREAS, should GSX be permitted the maximum allowable hazardous waste discharge for the Lumber River it would mean that no other industry would be able to discharge any quantity of these waste into the Lumber River; and

WHEREAS, this would paralyze some of the industrial growth not only in Columbus County, but also in Robeson County, Scotland County, Hoke County, Montgomery County, and Moore County; and

WHEREAS, the Columbus County Board of Commissioners has previously stated its opposition to this facility being permitted.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Columbus County that the State of North Carolina is requested to deny any and all hazardous waste permits until such time as the Waste Treatment Commission and other agencies have fully evaluated their studies of need, methodology, site selection and operation. That public hearings are currently being held studying this issue and that to issue a permit at this time would be premature and an attempt to circumvent practices currently being implemented.

A motion was made by Commissioner Norris, seconded by Commissioner Dew and passed unanimously to extend the payback of the Literary Funds by one (1) year as requested by the Whiteville School Board.

BOARD UPDATE

The Administrator updated the Board on the following items:

1. The September 2, 1986 minutes indicate the name "Robert" Gore was hired in the Tax Department and it should be "Richard" Gore. The Board concurred to the appropriate change.

2. Suggested topics for Resolutions to present to the County Commissioners Association are as follows: Inventory Tax; Tort Reform; Mandated Programs; Education; Waste to Energy; Hwy 74-76 from Chadbourn to Lumberton; Board of Commissioners sitting as Health and Social Services Board; Law Enforcement Officers' Benefits.

The Board advised the Administrator to draft resolutions on topics mentioned and present to them for review.

3. Additional retirement benefit provided by the last session of the General Assembly for the Law Enforcement Officers.

4. New Federal Law concerning Group Hospitalization Insurance requires that any employee leaving the County's service be allowed to remain on the County's policy for a period of up to three (3) years.

7. Paul C. Gore has established a recreational area for the County's 4-H'ers and Boy Scouts at Spring Lake, Pireway, North Carolina.

9. Revenue Sharing appears to be dead as of the last vote taken in the House.

10. After the adoption of the Fire District Map, which was signed by all parties concerned, a Resolution from the Town of Lake Waccamaw has been received opposing one of the boundaries.
