WHEREAS, in North Carolina the Lead Organizations, as voluntary organizations serving municipal and county governments, have established productive working relationships with the cities and counties across this state; and

WHEREAS, the 1987 General Assembly recognized this need through the appropriation of \$990,000 to help the Lead Regional Organizations assist local governments with grant applications, economic development, community development and to support local industrial development activities and other activities as deemed appropriate by their local governments; and

WHEREAS, these funds are not intended to be used for payment of member dues or assessments to a Lead Regional Organization or to supplant funds appropriated by the member governments; and

WHEREAS, in the event that a request is not made by the County of Columbus for release of these funds to our regional Council, the available funds will revert to the state's General Fund; and

WHEREAS, in Region O funds in the amount of \$55,000 will be used to/for economic and community development planning and grants administration, regional data center activities, local technical assistance, and other functions approved by our Executive Committee.

NOW, THEREFORE BE IT RESOLVED, that the Columbus County Board of Commissioners requests the release of its share of these funds, \$9,772.68 to the Region O Council of Governments at the earliest possible time in accordance with the provisions of Chapter 830 of the 1987 Session Laws (HB 1515).
