The Board reached a general concensus to delete from the agenda consideration of Resolution supporting other counties request that the Lumber River between Fair Bluff and Lumberton be in the Natural and Scenic Rivers System as a Resolution was adopted by the Columbus County Board of Commissioners on February 17, 1987, designating that the Lumber Rier wherever it forms a boundary of Columbus County be a potential component of the North Carolina Natural and Scenic Rivers System, according to the 1985 amendment of G.S. 113A-36.

to take the commodities to facilities in established areas of the County. The distribution to receipents will have to be finalized. The Board voiced their approval of the plan.
