BE IT RESOLVED by the Board of Commissioners for the County of Columbus, North Carolina:

Section 1. The Board hereby finds and approves the matters hereinabove set forth.

Section 2. The Board hereby authorized the County of Columbus to participate in the Authority and hereby directs that a certified copy of this resolution be filed with the Authority, in care of North Carolina Department of Commerce (Attention: Bruce Strickland, Jr.,), as an application for membership in the Authority.

Section 3. Samuel G. Koonce is hereby appointed by the Board as the Commissioner of the Authority for the County of Columbus, and shall serve at the pleasure of the Board and may be removed, with or without cause, by the Board, and said Commissioner before entering upon his duties shall take and subscribe to an oath before some person authorized by law to administer oaths to execute the duties of his office faithfully and impartially, and a record of such oath shall be filed with the Clerk to the Board and spread upon its minutes.

Section 4. The Clerk to the Board is hereby authorized and directed to execute and deliver a certified copy of this resolution to the Authority, in accordance with Section 2 hereof, the Commissioner appointed to the Authority and the officers of the Board and employees of the County are hereby authorized to do all things necessary to carry forward the purpose of this resolution.

Section 5. This resolution shall take effect immediately upon its passage.
