The meeting was called to order by the Chairman and the invocation was given by Dr. Roger Gilbert, Pastor of the First Baptist Church.

RESOLUTION ADOPTED AVERAGE WEEKLY WAGE - JASPER TEXTILES

The Board of Commissioners for the County of Columbus, North Carolina, met in regular session in the Commissioners' Meeting Room of the Columbus County Administrative Building in Whiteville, North Carolina, the regular place of meeting, at 9:00 A.M., on July 5, 1988.

The following Commissioners were present:

Commissioners Junior Dew, Samuel G. Koonce, Lynwood Norris, Ed Worley, and Giles E. (Buddy) Byrd.

Absent: None

Also Present: Lewis Sauls, Counsel to the Columbus County Industrial Facilities and Pollution Control Financing Authority; Roy Lowe, County Administrator; James E. Hill, Jr., County Attorney; Ida L. Smith, Deputy Clerk; Clara Cartrette, News Reporter; Deuce Niven, Tabor City Tribune; Scott Whisnant, Star News.

At 9:00 A.M., Mr. Lowe, County Administrator, reported that he had been advised that the average weekly manufacturing wage proposed to be paid by Jasper Textiles, Inc. (the "Company") as part of the Project (as hereinafter defined) in Columbus County was lower than the average weekly manufacturing wage paid by all manufacturers in Columbus County and that for such reason the proposed application to be submitted to the Deartment of Commerce by The Columbus County Industrial Facilities and Pollution Control Financing Authority (the "Authority") for approval of the Project (as hereinafter defined) may not be approved.

Mr. Lowe pointed out that G.S. 159C-7 provides that where a company such as Jasper Textiles, Inc. will not pay an average weekly manufacturing wage paid in the County or which is not less than ten percent (10%) above the average weekly manufacturing wage paid in the State that the Secretary of the Department of

Commerce may nonetheless approve the proposed industrial project if he shall have received (i) a resolution of the governing body of the County requesting that the proposed industrial project be approved notwithstanding that the operator will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in the County and (ii) a letter from an appropriate State official, selected by the Secretary, to the effect that unemployment in the County is "especially severe".

Mr. Lowe reported that the unemployment rate for Columbus County was for the latest available period such that under proposed regulations of the Department of Commerce, the Secretary can approve the Project (as hereinafter defined) since unemployment in Columbus County would be "especially severe" under the proposed regulations.

The Company, in its Memorandum of Agreement with the Authority, dated January 21, 1988, as amended, has represented that the financing of the Project (as hereinafter defined) by the Authority will serve the purposes of Chapter 159C of the General Statutes of North Carolina, as amended, in that the Project (as hereinafter defined) will alleviate unemployment by creating employment for approximately 200 persons in Columbus County and the surrounding area.

Mr. Lowe suggested that the Board of Commissioners for the County of Columbus consider adopting the necessary resolution requesting the Secretary of the Department of Commerce to approve the Project (as hereinafter defined) for the Company, notwithstanding that the Company will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in Columbus County.

Commissioner Junior Dew introduced the following resolution, a copy of which had been distributed to each Commissioner and the title of which was read:

RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE COUNTY OF COLUMBUS REQUESTING THE SECRETARY OF THE DEPARTMENT OF COMMERCE TO APPROVE A PROJECT FOR JASPER TEXTILES, INC. NOTWITHSTANDING THAT JASPER TEXTILES, INC. WILL NOT PAY AN AVERAGE WEEKLY MANUFACTURING WAGE ABOVE THE AVERAGE WEEKLY MANUFACTURING WAGE PAID IN COLUMBUS COUNTY.

WHEREAS, the Columbus County Industrial Facilities and Pollution Control Financing Authority (the "Authority") has agreed to issue its qualified small issue revenue bonds in an aggregate principal amount not exceeding \$1,000,000 to pay all or a portion of the cost of the construction of a building and the acquisition and installation therein of machinery and equipment, all to be located adjacent to Jasper Textiles, Inc.'s present facility on Maultsby Street near the Whiteville City limits in Columbus County (the "Project"), and in accordance with the provisions of G.S. 159C-7 will file shortly with the Secretary of the Department of Commerce an application for the approval of the Project; and

WHEREAS, subparagraph (1)a of G.S. 159-C7 of the General Statutes of the State of North Carolina provides;

"The Secretary (of the Department of Commerce) shall not approve any proposed project unless he shall make all of the following, applicable findings:

1. In the case of a proposed industrial project, (a) that the operator of the proposed project pays, or has agreed to pay thereafter, an average weekly manufacturing wage (i) which is above the average weekly manufacturing wage paid in the county, or (ii) which is not less than ten percent (10%) above the average weekly manufacturing wage paid in the State * * *."

and

WHEREAS, G.S. 159C-7 also provides that

"In any case where the Secretary shall make all of the required findings respecting a proposed industrial project except that prescribed in subparagraph (1)a of this section, the Secretary may, in his discretion, approve the proposed project if he shall have received (i) a resolution of the governing body of the County requesting that the proposed roject be approved notwithstanding that the operator will not pay an average weekly manufacturing wage above the average weekly manufacturing wage in the County and (ii) a letter from an appropriate State official, selected by the Secretary, to the effect that unemployment in the county is especially severe."

WHEREAS, Jasper Textiles, Inc. (the "Company") cannot represent that the Company expects to pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in Columbus County; and

WHEREAS, the Company has represented that the Project will create employment for approximately 200 persons in Columbus County and the surrounding area; and

WHEREAS, the Board of Commissioners for the County of Columbus (the "Board") has determined to request that the Secretary of the Department of Commerce approve the Project notwithstanding that the Company will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in Columbus County;

NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

- 1. Because unemployment in Columbus County is, in its opinion, especially severe, the Board does hereby request that the Secretary of the Department of Commerce approve the Project pursuant to G.S. 159C-7, notwithstanding that the Company will not pay an average weekly manufacturing wage above the average weekly manufacturing wage paid in Columbus County.
- 2. The Clerk to the Board is directed to file a certified copy of this resolution with Department of Commerce.
 - 3. This resolution shall take effect immediately upon its passage.

Commissioner Byrd moved passage of the foregoing resolution entitled:
"RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE COUNTY OF COLUMBUS REQUESTING
THE SECRETARY OF THE DEPARTMENT OF COMMERCE TO APPROVE A PROJECT FOR JASPER
TEXTILES, INC. NOTWITHSTANDING THAT JASPER TEXTILES, INC. WILL NOT PAY AN AVERAGE
WEEKLY MANUFACTURING WAGE ABOVE THE AVERAGE WEEKLY MANUFACTURING WAGE PAID IN
COLUMBUS COUNTY", Commissioner Koonce seconded the motion, and the resolution was
passed by the following vote:
