ZONING - REQUEST FOR CHANGE IN SCC AREA & PUBLIC HEARING SCHEDULED

A letter was presented to the Board from Les High and John Thompson requesting a zoning change in the Southeastern Community College Zoning District from R-20 (Residential Agricultural) to Multi-Family-Need and to establish a Public Hearing and notification of adjoining property owners.

A motion was made by Commissioner Norris, seconded by Commissioner Byrd and passed unanimously to allow the Board of Commissioners to act as a Planning Board and to schedule a public hearing on the zoning request at 7:15 P.M., November 7, 1988.

SOCIAL SERVICES - REQUEST & APPROVAL FOR ADDITIONAL EMPLOYEES TO PROCESS THE NEW CATASTROPHIC MEDICARE PROGRAM

Jo Anne Vereen, Social Services Director, addressed the Board on a new Catastrophic Medicare Program which allows Medicaid to provide extended insurance coverage for Medicare patients earning 80 percent or less of the national poverty level. Mrs. Vereen requested the employment of three (3) additional employees to process and monitor the program at annual salaries of \$11,400 each, plus fringe benefits. The County's cost for the balance of this fiscal year will be approximately \$15,108.

A motion was made by Commissioner Worley, seconded by Commissioner Koonce and passed unanimously to approve the request of employing three (3) additional employees to process and monitor the program. A budget amendment will be made upon the determination of the date these positions will be filled.

DOT - REQUEST FOR INSTALLATION OF CAUTION SIGNS AT INTERSTIONS US 74 and SR 1001, SR 1735 and SR 1740

Commissioner Byrd requested that Mr. Robert Crumpler, DOT District Engineer, to investigate the possibility of installing caution alerts at the intersections of US 74, SR 1001, SR 1735, and SR 1740 as several fatal accidents have happened since the opening of the new four-lane 74-76.

Mr. Crumpler stated that he would conduct a study on the above mentioned

intersections and report his findings back to the Board.

The Chairman thanked Mr. Crumpler and Mr. Goff for their attendance.
