**APPROVAL OF MINUTES**

**RESOLUTION - ENDORSING A BOND REFERENDUM FOR EDUCATIONAL FACILITIES**

A motion was made by Commissioner Worley, seconded by Commissioner Norris and passed unanimously to adopt a Resolution endorsing a Bond Referendum for Columbus County School facilities as follows:

**R E S O L U T I O N**

THE BOARD OF COUNTY COMMISSIONERS of Columbus County, North Carolina, at their regular meeting on the 3rd day of April, 1989, at Whiteville, Columbus County, North Carolina, unanimously adopted the following Resolution.

**W I T N E S S E T H :**

WHEREAS, the Columbus County Board of Commissioners endorses a 17.5 Million Dollar Bond Referendum to provide educational school facilities to be designated as follows: Columbus County Schools 12.3 Million Dollars; Whiteville City Schools 4.1 Million Dollars; and Southeastern Community College 1.1 Million Dollars; and

WHEREAS, the Columbus County Board of Commissioners supports the improvements of the educational system which will result in economic, social and cultural improvements for all citizens of Columbus County.

NOW, THEREFORE, BE IT RESOLVED that the Columbus County Board of Commissioners hereby authorize James E. Hill, Jr., County Attorney, and Roy L. **RESOLUTION - PREPAYMENT OF TAXES**

**TAX - APPROVAL OF ADVERTISEMENT FOR UNPAID TAXES**

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to allow the Tax Administrator, W.D. Brooks, advertise tax liens for personal property and real estate. **TAX - AUTHORIZATION TO BILL TAXES FOR TOWN OF FAIR BLUFF**

**BRUNSWICK VOLUNTEER FIRE DEPARTMENT - REQUEST APPROVED FOR PUBLIC HEARING FOR PROPOSED FIRE SERVICE DISTRICT**

A motion was made by Commissioner Worley, seconded by Commissioner Norris and passed unanimously to schedule a public hearing for a proposed Fire Service District for the Brunswick Volunteer Fire Department on May 9, 1988, at

7:30 P.M., at the Brunswick Fire Station as requested by the Brunswick Fire Chief, Robert McQueen.

**BUCKHEAD VOLUNTEER FIRE DEPARTMENT - APPROVAL OF RADIO PURCHASE FOR FIRE PUMPER**

A motion was made by Commissioner Byrd, seconded by Commissioner Dew and passed unanimously to approve the purchase of a radio from Broadcast Communications for the amount of \$918.00 to be installed on a 1975 Ford Truck C750 Pumper for the Buckhead Volunteer Fire Department as requested by the Emergency Management Coordinator, Howard Stanley.

Also, approve a budget amendment in the amount of \$918.00 to be appropriated from Non-Departmental Contingencies (10-660-9999) to be expended in Special Appropriations - Radio for Buckhead Volunteer Fire Department (10-690-9501).

**AGREEMENT FOR DISTRIBUTION OF FOOD COMMODITIES - FOUR COUNTY COMMUNITY SERVICES**

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to approve an Agreement with Four County Community Services for the distribution of food commodities. Agreement is as follows:

AGREEMENT

THIS AGREEMENT, made and entered into as of this 3rd day of April, 1989, by and between Columbus County, North Carolina, hereinafter called "County"; and the FOUR-COUNTY COMMUNITY SERVICES, INC., hereinafter called "FCCS";

W I T N E S S E T H :

WHEREAS, certain Federal commodities are now available to Columbus County through the North Carolina Department of Agriculture (NCDA) for distribution to eligible persons, through a local Emergency Feeding Organization (EFO); and

WHEREAS, pursuant to State regulations, it is permissible for Counties to contract with appropriate outside agencies to administer the program under which funds are distributed; and

WHEREAS, Columbus County desires to contract with FCCS for this purpose, and the FCCS desires to act as the EFO for the distribution of commodity foods;

IN CONSIDERATION OF THE COVENANTS AND AGREEMENTS HEREIN CONTAINED, BOTH PARTIES AGREE AS FOLLOWS:

1. The County and the FCCS agree that they must comply with all the terms and provisions of the Emergency Food Assistance Agreement (TEFAP - 1/7/87) dated April 3, 1989 by and between the NCDA and the County, both of which are incorporated hereto by reference;

2. COUNTY RESPONSIBILITIES

It shall be the responsibility of the County to:

- a. provide initial and ongoing training;
- b. provide verification of income and notices to recipients;
- c. provide list of eligible recipients along with other pertinent data to FCCS;

- d. provide hearing officers for any local appeals;
- e. provide administrative cleanup activities at the end of the Contract;
- f. act as liaison between the State and FCCS;
- g. reserve the right to have a County Auditor review any facet of the administration of this program;
- h. maintain a record of:
  - (1) names & address of all persons eligible to receive USDA foods;
  - (2) type of documentation used to determine income eligibility;
  - (3) household size;
  - (4) actual costs incurred for storage and distribution of donated foods;
  - (5) for each distribution, documentation for food items distributed and distribution rate for each item;
- e. prepare and submit any/all programmatic reports to NCDA;
- f. retain all programmatic records for a period of three (3) years from the close of the federal fiscal year (October 1 - September 30) to which they pertain;
- g. permit NCDA and/or USDA representative to inspect donated foods in storage, or facilities used in the handling or storage of such donated foods, and to review or audit all records, including financial, at any reasonable time.

*EXCEPTION: FCCS will not be held responsible for shortage or unaccountables in which there is not negligence evident on the part of FCCS.*

#### 4. INSURANCE

FCCS and Columbus County will individually insure their respective agencies, employees, agents and assigns against all loss, cost, damages, expense and liability caused by an accident or other occurrence resulting in bodily injury, including death, sickness and disease to any person; or damage or destruction to property, real or personal, arising directly or indirectly from operations, products or services rendered under this Contract.

Both FCCS and Columbus County agree to individually purchase and maintain during the life of this Contract with insurance companies acceptable to Columbus County, authorized to do business in the State of North Carolina, the following insurance purchased and maintained separately:

##### COMPREHENSIVE GENERAL LIABILITY

Bodily injury and property damage liability insurance as shall protect Columbus County, its agents, employees, and assigns, and FCCS, its agents, employees, and assigns, each independent of the other, performing work under this Contract from claims of bodily injury which arise from operations of this Contract. The amounts of such insurance shall not be less than Three Hundred Thousand (\$300,000.00) Dollars bodily injury liability each occurrence and aggregate a figure of One Million (\$1,000,000.00) Dollars. This insurance shall include coverage for products/completed operations, contractual liability assumed under this provision of this Contract and broad form property damage. The County will provide any additional insurance as is deemed necessary by the County to satisfy NCDA requirements concerning negligence in instances of theft.

WORKMEN'S COMPENSTION AND OCCUPATIONAL DISEASE INSURANCE

Meeting the statutory requirement of the State of North Carolina including employers' liability insurance for an amount of not less than One Hundred Thousand (\$100,000) Dollars. Certificates of such insurance will be furnished to the County and shall contain the provision that the County be given thirty (30) days written notice of any intent to amend or terminate by either FCCS or the insuring company.

Prior to the distribution of any commodities hereunder the County shall be responsible that such insurance policies purchased by FCCS comply with the terms of this Contract.

5. TERMS OF AGREEMENT

This agreement shall begin April 3, 1989 and shall continue until cancelled by mutual agreement.

Commissioner Norris withdrew his second from Commissioner Worley's motion and seconded Commissioner Dew's motion.

Commissioner Koonce requested permission to abstain from voting as his voting would be a conflict of interest.

The Board concurred with his request.


James E. Hill, Jr., County Attorney, was directed by the Board to draw up the contract with United Carolina Bank and present to the Board for approval.
