The Chairman called the meeting to order and the invocation was given by the Reverend Wade Fowler.

APPROVAL OF MINUTES

A motion was made by Commissioner Norris, seconded by Commissioner Dew and passed unanimously to approve the minutes of the August 21, 1989, Board Meeting, as recorded.

PROCLAMATION - AMERICAN HEART'S FOOD FESTIVAL WEEK

A motion was made by Commissioner Worley, seconded by Commissioner Byrd and passed unanimously to proclaim the week of September 10 through September 16 as "American Heart's Food Festival WEEK".

PROCLAMATION

WHEREAS, heart and blood vessel diseases kill more men, women and children in this country than any other cause of death. Scientists have demonstrated that the typical American diet -- high in cholestrol and saturated fat -- contributes to high blood cholesterol, a major risk of heart attack; and

WHEREAS, when the body accumulates too much fat and cholesterol, the excess can collect in the walls of arteries, forming deposits called "plaque." If the accumulation of plaque is allowed to progress over the years, an artery can become completely clogged with fats, cholesterol and other debris. If the artery supplies the heart, the result can be a heart attack; if it supplies the brain, the result can be a stroke; and

WHEREAS, medical scientists tell us that lowering the level of cholesterol and saturated fat in the diet can reduce one of the risks of coronary disease. By limiting cholesterol consumption to less than 300 milligrams per day and fat intake to less than 30 percent of daily calories, most healthy men, women and children over two years old can control blood cholesterol levels and reduce the risk of heart attack and stroke; and

WHEREAS, American Heart's Food Festival is an educational event to promote "help your heart" eating. During the festival, area food retailers and the American Heart Association work together to promote good nutrition. The Food Festival helps local grocery stores encourage consumers to purchase nutritional

foods and to become aware of eating habits which can help reduce the risk of heart disease and stroke; and

WHEREAS, as part of an ongoing effort to help North Carolinans learn more about their cardiovascular systems and their overall heart-health, the American Heart Association, North Carolina Affiliate will conduct its fifth annual American Heart's Food Festival Week September 10-16.

NOW, THEREFORE, the COLUMBUS COUNTY BOARD OF COMMISSIONERS, do hereby proclaim September 10 through September 16 as "American Heart's Food Festival Week" in Columbus County, and urge all our citizens to join in learning more about proper nutrition and practicing good nutritional habits for better health.

TAX - REQUEST TO EXCLUDE WOODED ACRES SUBDIVISION FROM THE HALLSBORO TAX SERVICE DISTRICT

COUNTYWIDE DISTRICTED WATER - PREAPPLICATION CONFERENCE

James E. Hill, Jr. reported on the preapplication conference that was held with Farmers Home Administration on August 31, 1989 in reference to the Countywide Districted Water Project.

Attorney Hill stated that he anticipates having the Committee formed by October 1, 1989, which will be the Board of Columbus County Commissioners with the application to be placed with USDA FHA in Raleigh, NC by October 15, 1989.

LEGAL & PROFESSIONAL - APPROVAL OF ATTORNEY FILING OBJECTION OF TRANSFERRING WATER FROM CAPE FEAR WATER BASIN TO NEUSE RIVER

James E. Hill, Jr., County Attorney, advised the Board that he had been faxed a copy of a letter from Bill Lynch, an attorney for the Lower Cape Fear Water and Sewer Authority, on September 1, 1989, stating that it has been brought to his attention that Lawrence Davis, a Raleigh Attorney, is representing the towns of Cary and Apex and they are proposing to take from the Cape Fear Water Basin 16,000,000 gallons of water per day and discharge through their plants and facilities to be discharged in the Neuse River Water Basin. This is asking for a transfer from the Cape Fear Water Basin to the Neuse River Water Basin. Bladen, New Hanover, Brunswick and Cumberland counties are fighting this transfer of water from one basin to the other and the Lower Cape Fear Water and Sewer Authority is asking if we will participate in the objection to this action.

A motion was made by Commissioner Worley, seconded by Commissioner Norris and passed unanimously to authorize James E. Hill, Jr., the County Attorney, to file a letter of objection in reference to the proposal.

COLUMBUS COUNTY SCHOOLS - APPROVAL OF PLAQUE PRESENTATION TO WEST COLUMBUS GIRLS' VOLLEYBALL TEAM

A motion was made by Commissioner Norris, seconded by Commissioner Byrd and passed unanimously to present a plaque of appreciation to the West Columbus Girls' Volleyball Team for tieing for first place in the 1989 Waccamaw Conference.

RECREATION - CONSIDERATION OF APPOINTMENT OF BOARD OF DIRECTORS

The Chairman stated that he had been contacted about the reorganizing of the Columbus County Recreation Department Board of Directors. The County has a need for this Board to supervise and assist in planning the Recreation needs of the County. We need to know how we want to pursue the reorganization and who served on the Board when it was active.
