INTERBASIN TRANSFER OF WATER - APPROVAL OF LEGAL FEES

The Administrator presented a letter from the Lower Cape Fear Water and Sewer Authority requesting the County to proportionately share costs incurred in legal fees, to date, of \$4,026.50 in regards to the opposition of the interbasin transfer of water that the Environmental Management Commission approved for the Towns of Cary and Apex, and efforts to prohibit interbasin transfers of water in general in the future.

COUNTY SCHOOL - DISCUSSION OF LOCATION OF SOUTH COLUMBUS HIGH SCHOOL

A delegation of four (4) concerned citizens, addressed the Board concerning the proposed location of the South Columbus High School.

Chairman Byrd told the group, before the spokesman began, that the Board of Commissioners have no input into the school site selection and that by State Statute, the decision is to be made by the Board of Education.

Ronnie Stanley, spokesman for the group, stated that he wanted to notify the Board of Commissioners of their intentions. We have a few objectives; one is a centralized school, and another is equal education and opportunity for all students. We feel that the proposed location of the South Columbus High School is an injustice to the children in the Guideway, Pireway, Nakina and Old Dock areas of the County.

James E. Hill, Jr., County Attorney, explained to the group that the Commissioners have no role in the school site location issue, except to appropriate the funds and they must be used as designated for in the bond referendum which passed in September, 1989.
