COLUMBUS COUNTY
1989 COMMUNITY DEVELOPMENT BLOCK GRANT-HOUSING DEMONSTRATION
PROJECT ORDINANCE

Be it ordained by the Columbus County Board of County Commissioners that, pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following grant project ordinance is hereby adopted:

Section 1. The project authorized is the Community Development project described in the work statement contained in the grant agreement # between this unit and the Department of Economic and Community Development. This project is more familiarly known as the Waccamaw-Siouan Housing Demonstration Project.

Section 2. The officers of this unit are hereby directed to proceed with the grant project within the terms of the grant document, the rules and regulations of the Department of Economic and Community Development and the budget contained herein.

Section 3. The following revenues are anticipated to be available to complete this project:

Section 5. The finance officer is hereby directed to maintain within the Grant Project Fund sufficient specific detailed accounting records to provide the accounting to the grantor agency required by the grant agreement and federal and state regulations.

Section 6. Funds may be advanced from the General Fund for the purpose of making payments as due. Reimbursement requests should be made to the grantor agency in an orderly and timely manner.

Section 7. The finance officer is directed to report monthly on the financial status of each project element in Section 4 and on the total grant revenues received or claimed.

Section 8. The budget officer is directed to include a detailed analysis of past and future costs and revenues on this grant project in every budget submission made to this board.

Section 9. Copies of this grant ordinance shall be made available to the budget officer and the finance officer for direction in carrying out this project.

COUNTY BUILDINGS - ROOF CONTRACT AMENDMENT WITH E.L. HAWKS, INC.

The Administrator presented a letter from E.L. Hawks, Incorporated, stating that the original contract that he had submitted for the Miller Building roofing replacement was to install 2" of insulation and in order to build the roof level to the existing 3", it will take another 1". The additional insulation, labor and material will cost a total of \$3,200.00.

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to approve an amendment to the Miller Building roof replacment contract with E.L. Hawks, Incorporated, including the additional 1" Per-lite insulation to bring the roof level up to the existing roof level of 3" at an additional cost of \$3,200.00. These funds are to be expended from the Miller Building 1989-90 Operating Budget.

EXECUTIVE SESSION

RECYCLING - APPROVAL TO SUBMIT BID ON TOW MOTOR

A motion was made by Commissioner Dew, seconded by Commissioner Koonce and passed unanimously to allow Dempsey Herring, Recreation Director, to submit a bid to N.C. State Surplus for a tow motor for the Recycling Project, not to exceed \$2,500.00. If the bid is successful, funds are to be appropriated from the General Fund Balance.

COUNTY DISTRICTED WATER SYSTEM - DISCUSSION WITH CITIZENS

Approximately seven (7) Columbus County citizens questioned the Board of County Commissioners in reference to the proposed Columbus County Districted Water System - Phase I for the Williams and South Williams Project.

The Chairman stated that an application has been filed for Federal Assistance (grant monies that will fund 50-75% of an estimated 3.8 million dollar water project) for the construction of the proposed first phase of the County-wide Water System to be comprised of the entire Williams and South Williams Townships, including the Town of Tabor City.


Upon notification of the grant funds to be received, a Bond Referendum will be called wherein the registered voters of the district will vote on the referendum for the amount of difference between the grant funding and the total cost of the revised water project.


There was a question and answer session between the citizens in attendance and the County Commissioners concerning the proposed districted water system for Williams and South Williams Townships.
