Chairman Byrd called the meeting to order and Commissioner Worley gave the invocation.

APPROVAL OF MINUTES

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to approve the minutes of the March 5, 1990 Board meeting, as recorded.

Commissioner Byrd requested that a statement be added to the minutes of the March 5, 1990 meeting; that the reason for his absence from the Board meeting was due to the illness of his niece.

AIRPORT - GRANT FUNDS DENIED FOR IMPROVEMENT

The Administrator presented a letter from the North Carolina Department of Transportation offering Columbus County a grant in the amount of \$5,500, provided that the County match the amount with local funds for the airport improvement Aviation Element of 1990.

A motion was made by Commissioner Worley, seconded by Commissioner Norris and passed unanimously to write a letter to the N.C. Department of Transportation denying the request for funding in the amount of \$5,500 to the Columbus County Airport for airport improvements.

ZONING AND BUILDING INSPECTION - TOWN OF FAIR BLUFF REQUEST TABLED

A motion was made by Commissioner Norris, seconded by Commissioner

Worley and passed unanimously to table the request from the Town of Fair Bluff for

the County to release extraterritorial jurisdiction to the Town of Fair Bluff for

zoning and building inspection purposes until the next fiscal year (1990-91).

APPOINTMENT - SOUTHEASTERN ECONOMIC DEVELOPMENT COMMISSION

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to re-appoint Mr. Leo Mercer to serve on the Southeastern Economic Development Commissioner Board for a three (3) year term, with term expiring April 1, 1993.

BUDGET AMENDMENT - DEBT SERVICE

A motion was made by Commissioner Koonce, seconded by Commissioner Norris and passed unanimously to approve a budget amendment in Debt Service in the amount of \$80,251.00 that was inadvertently omitted from the 1989-90 Operating Budget by the former Finance Officer. Funds are to be appropriated from the Fund Balance (10-399-0000) and to be expended in Debt Service (10-690-2000).

BUDGET AMENDMENT - SHERIFF'S DEPT.

A motion was made by Commissioner Worley, seconded by Commissioner Norris and passed unanimously to accept revenue in the amount of \$4,038.00 from a Federal drug forfeiture action (10-349-0000) to be expended in Capital Outlay -Drug Enforcement (10-510-7401).

BUDGET AMENDMENT - RECYCLING

A motion was made by Commissioner Norris, seconded by Commissioner Dew and passed unanimously to approve appropriating funds in the amount of \$8,000.00 from Non-Departmental - Contingency (10-660-9999) to be expended in the Recycling Program, with the stipulation that no other revenue will be appropriated for expenditures in the Recycling program until the Board decides a definite direction to pursue a recycling program in Columbus County.

COUNTY SCHOOLS – AUTHORIZATION OF PLAQUE PRESENTATION TO TABOR CITY GIRLS' BASKETBALL TEAM

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to approve presenting the Tabor City Girls' Basketball Team with a "Plaque of Appreciation" for their achievement in advancing to the State Finals and placing second in the State Championship. CITY SCHOOLS - APPROVED ADVANCEMENT OF \$100,000 BOND FUNDS

The Administrator presented a letter from the Whiteville City Board of

Education requesting ONE HUNDRED THOUSAND DOLLARS (\$100,000) in advance in order to pay the architectural fees for the Whitevile City School projects. A motion was made by Commissioner Worley, seconded by Commissioner Koonce and passed unanimously to advance the Whiteville City Board of Education the sum of ONE HUNDRED THOUSAND DOLLARS (\$100,000), to be repaid to the county from the first sale of the bonds, plus reimbursement at the ongoing interest rate, during the time of use. The advancement shall be in accordance with the Resolution Concerning the Funding of School Facilities Projects in Anticipation of Issuing Bonds, formerly adopted by the Columbus County Board of Commissioners on February 5, 1990, Minute Book 20, Pages 539 and 540. The motion further stated that as of March 26, 1990, all advancement of funds to County and City Schools' shall be frozen and funding for school projects will only be funded when bonds are sold.

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to adjourn the meeting at 8:40 P.M.
