U.S. POSTAL SERVICE - REQUEST & APPROVAL OF NUMBERING NEW SUB-DIVISION HOUSING

Mr. Billy Martin, Postmaster of the U.S. Post Office in Whiteville, requested the Board's permission to begin numbering houses in new sub-divisions in Columbus County and requested the Board consider the numbering of all houses in Columbus County, in the future.

A motion was made by Commissioner Koonce, seconded by Commissioner Norris and passed unanimously to accept Postmaster Billy Martin's proposal to begin numbering houses in any new sub-division.

COLUMBUS COUNTY AIRPORT - APPROVAL OF FIVE YEAR AIRPORT IMPROVEMENT PLAN

Fred Hobbs, representing Hobbs, Upchurch and Associates, addressed the Board on the Submissions for the 1991-1995 Transportation Improvement Program to develop a joint five year program which will constitute both the Transportation Improvement Program for all airports and FAA's Capital Improvement Program for general aviation.

A motion was made by Commissioner Dew, seconded by Commissioner Worley and passed unanimously to approve the submission of the 1991-1995 Transportation Program application to update the Columbus County Airport plan subject to the availability of matching funds from the County.

COLUMBUS COUNTY DISTRICTED PROPOSED WATER PROJECT - ENVIRONMENTAL ASSESSMENT

Fred Hobbs, representing Hobbs, Upchurch and Associates, updated the Board on the further processing of the loan application for the Columbus County Water-Sewer District Phase I. Mr. Hobbs stated that before any further processing of the loan application, the County must publish a Preliminary Notice "Impacts on Wetlands". During the Environmental Impact Assessment, it has been determined by the U.S. Fish and Wildlife that conditions are favorable in Columbus County for certain Natural Resources and a survey must be conducted to determine if Federal and State listed endangered species; Carolina Grass-of-Parnassus and dissected sneezeweed will be affected; therefore, there will have to be a biological survey performed at an approximate cost of \$25,000.00.

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to table the request for the biological survey and advised the administrator to negotiate costs with other contractors in the area and upon receiving more information to present it to the Board for consideration.

LIBRARY - REQUEST FROM CHADBOURN FOR A BRANCH

Ms. Edna Yates, presented a resolution adopted by the Chadbourn Town Council requesting that the County establish a branch of the Columbus County Library within the Town limits of Chadbourn at the earliest time possible.

A motion was made by Commissioner Koonce, seconded by Commissioner Norris and passed unanimously to refer the request through the Columbus County Public Library Board as this is the normal procedure for proposed libraries to be established.

VETERANS COUNCIL - REQUEST TO EMPLOY A TEMPORARY VETERANS' ADMINISTRATOR

Mr. Charles Simmons, President of the Veterans Council, addressed the Board on the community projects that the Veterans Council is sponsoring, including a blood drive to be held July 20, 1990. Mr. Simmons requested that a temporary replacement (recommendation Randy Ward) be made for Junior Cribb, Veterans' Service Officer, until Mr. Cribb returns to work.

A motion was made by Commissioner Dew, seconded by Commissioner Koonce and passed unanimously to direct the Administrator to place an advertisement with the Employment Security Commission of the temporary position available and receive applications and present to the County for consideration.

SOUTHEASTERN COMMUNITY COLLEGE - REQUEST AND APPROVAL OF ADVANCEMENT

The Administrator presented a request from Southeastern Community College to advance funds in the amount of \$5,775.00 to pay architectural services for the SCC roofing project to be repaid from the bond proceeds.

A motion was made by Commissioner Worley, seconded by Commissioner Koonce and passed unanimously to approve advancing funds in the amount of \$5,775.00, plus interest for the time used at the same rate the County would receive had the funds been invested.

EMERGENCY MANAGEMENT - MEDICAL ALERT REQUEST & APPROVAL TO USE COUNTY FREQUENCY

A motion was made by Commissioner Koonce, seconded by Commissioner Norris and passed unanimously to approve Medical Alert Transportation Services permission to install a 100 watt base unit to the County Emergency Fire and Rescue Frequency.

SENIOR CENTER - BID AWARDED FOR ADDITION

The Administrator presented the Board with the following bids on the renovation of the Senior Center in Whiteville, N.C.

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to award the bid to the low bidder, Rooks Construction, Incorporated in the amount of \$51,798.00, allocating funds in the amount of \$30,477.00 from Non-Departmental Contingencies with the balance of \$22,433.00 to be appropriated from the Cape Fear Council of Governments.

The Administration office was notified on June 6, 1990, that a change order was to be made on the project as the architect had used 6" block walls in the specifications and the Whiteville building code requires 8" blocks with an additional cost of \$790.00.

Upon negotiation with Commissioner Lynwood Norris and Rooks Construction Company, the change order was reduced to \$490.00

After polling the majority of the Board, the Board reached a general consensus to concur with the change order as required with the negotiated price of \$490.00 with the funds to be appropriated from Non-Departmental Contingencies.


RESOLUTION - BOB KING MEMORIAM

A motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to schedule a public hearing for the Whiteville Rescue Unit, West Smith Street, Whiteville, NC, on January 25, 1990, at 7:30 P.M.

A motion was made by Commissioner Norris, seconded by Commissioner Worley and passed unanimously to schedule a public hearing for the Bolton Volunteer Fire and Rescue Department, Bolton, NC, on June 26, 1990, at 7:30 P.M.

A motion was made by Commissioner Norris, seconded by Commissioner Worley and passed unanimously to schedule a public hearing for the Old Dock/Cypress Creek Volunteer Fire Department, Route 4, Box 211F, Whiteville, NC on June 27, 1990, at 7:30 P.M.

The Board advised the Columbus County Fire and Rescue Departments that the boundary lines are considered to be temporary as Howard Stanley has been directed to request assistance for the State of North Carolina, who will draw the proposed boundary lines for each Fire Department and Rescue Squad and map each district with each unit signing off before the map is presented to the Board for adoption.
