DOT - ADOPTION OF RESOLUTION IN REFERENCE TO 1800 & 1802

Mr. Ossie Jacobs, Mr. Monroe Jacobs and Mr. Haynes Graham addressed the Board in reference to improving the condition of State Road 1800 and 1802 and requested the Board to adopt a Resolution to the proper authorities requesting consideration be given to upgrade these roads in the near future.

A motion was made by Commissioner Norris, seconded by Commissioner Dew and passed unanimously to adopt a Resolution of support to upgrade 1800 and 1802 to be sent to the N.C. Department of Transportation and Senator R.C. Soles, Jr. and Representative Leo Mercer for their consideration. Further, upon receiving an answer from the proper authorities to notify the Buckhead residents of the intent of the N.C. Department of Transportation and also furnish the residents with a copy of the Green Bill that was passed several years ago giving the authority to the N.C. Department of Transportation on setting road priorities.

ADMINISTRATION - AUTHORIZATION TO ADD EXTENSIONS TO TELEPHONE SYSTEM.

A motion was made by Commissioner Norris, seconded by Commissioner Dew and passed unanimously to approve the addition of sixteen (16) extensions to the present ROLM CBX telephone system at the estimated cost of \$3,900.00 to be expended from the Internal Service Fund (30-724-74).

PROCLAMATION - HUNTING & FISHING DAY

A motion was made by Commissioner Dew, seconded by Commissioner Norris and passed unanimously to proclaim September 22, 1990 as "Hunting and Fishing Day in Columbus County".

P R O C L A M A T I O N

WHEREAS, hunting and fishing have always been an important part of the American tradition. While these activities may no longer be necessary for survival - as in colonial times - they are still relevant today; and

WHEREAS, for over 100 years, sportsmen have been in the forefront of the conservation movement. Not content with merely vocalizing their support, hunters and fishermen requested special fees and taxes on their equipment which help pay for wildlife management and other conservation programs. Over the years, monies raised total over \$8 billion for conservation; and

WHEREAS, these sportsmen-financed programs have led to the dramatic comeback of many species such as white-tailed deer, elk, antelope and wild turkey and have benefited all wildlife; and

WHEREAS, individuals and through their organizations, hunters and fishermen volunteer countless hours of their time for local conservation projects and to raise funds for conservation.

THEREFORE, BE IT RESOLVED that the Columbus County Board of Commissioners would like to take this opportunity to commend hunters and fishermen for their efforts on behalf of wildlife and their contributions to conservation.

BE IT FURTHER RESOLVED that the Columbus County Board of Commissioners proclaim Saturday, September 22, 1990, as "Hunting and Fishing Day in Columbus County", and call upon all citizens to join with sportsmen-conservationists in their efforts to ensure the wise use and proper management of our natural resources to benefit future generations.

#### **STATE OF NORTH CAROLINA**

#### **COLUMBUS COUNTY**

#### C O N T R A C T

THIS CONTRACT made and entered into this 1st day of July, 1990, by and between the County of Columbus, a body politic, under the laws of the State of North Carolina, sometimes hereinafter referred to as "County" through the Columbus

County Health Department, sometimes referred to as "Health Department" and Ronald S. Mukamal, M.D., sometimes hereinafter referred to as "Physician";

W I T N E S S E T H :

**THAT WHEREAS,** the North Carolina General Statutes expressly allows Columbus County to appropriate funds for the purpose of facilitating health services within the said county; and

**WHEREAS,** the Columbus County Health Department and the Board of Health of Columbus County have contracted and agreed with Ronald S. Mukamal, M.D., to provide certain back-up services for the said department;

**NOW, THEREFORE,** in consideration of the premises and in further consideration of mutual terms and conditions set forth herein, the parties hereto covenant and agree as follows:

1. The said physician agrees to be available for professional services during the hours of 8:00 a.m. and 6.00 p.m. Monday through Friday. The exact number of hours will be left up to the weekly decision between the Doctor and the Columbus County Health Department as need be by the said department and as schedule allows by the said back-up physician.

2. The rate of pay for the hourly services by the said back-up physician shall be at the rate of Forty-seven (\$47.00) Dollars per hour, and that the said physician shall submit a bill within one month of rendering said services which shall be forwarded to the Columbus County Health Director for authorization of payment. The sum of Four Hundred (\$400.00) Dollars per month shall be paid for primary back-up and medical consultation services.

3. Any services rendered to the Columbus County Health Department's patients in the back-up physician's personal and private office or the Columbus County Hospital will be considered a separate contract not to be covered by this employment and is open to direct billing or negotiation between the said back-up physician and the patient or a third party payer and shall not be chargeable to the Columbus County Health Department unless specifically authorized for said billing in each and every case.

4. The back-up physician will serve the Columbus County Health Department with his professional services for which he is qualified according to the needs of said Health Department. These services basically shall include but are not limited to review of charts and signing of charts as back-up to nurse practitioners and physician assistants employed by the said Columbus County Health Department. Additionally, the said back-up physician shall be available for consultation with the Columbus County Health Director and professional staff on pertinent questions and shall also be available for direct patients care where the needs arises as determined by the Columbus County Health Department.

5. The back-up physician will serve as medical back-up to Columbus County Health Department and will serve as supplemental source of medical consultation as the needs may arise.

6. The back-up physician will be paid on a monthly basis for the number

of hours actually performed and worked during the pay period and these hours may vary from month to month depending upon the needs of the medical back-up physician and availability of scheduling.

7. This contract may be terminated between the back-up physician or the Columbus County Health Department by notification to Health Director or to the back-up physician, whichever the case may be in writing within thirty (30) days notice of said termination.

8. The back-up physician will maintain a one million dollar medical liability insurance coverage at their own expense while working in the Columbus County Health Department or maximum amount of available insurance as allowable by their insured if the same is less than one million dollars.

9. The Doctor serves as an independent contractor and is responsible for his own payment of social security taxes, federal income taxes, state income taxes, workman's compensation and other employment expenses.

**IN WITNESS WHEREOF**, the County of Columbus and the Board of Health of the the County of Columbus have caused this contract to be executed in its name, signed by its respective Chairpersons of the Board of Commissioners and Board of Health, attested by their respective clerks and the County of Columbus' seal affixed thereto, all by the authority of the Board of County Commissioners duly given and by the Board of Health duly given and the said RONALD S. MUKAMAL, M.D. has set his hand and seal as of the day and year first written above.

**C O N T R A C T**

THIS CONTRACT made and entered into by and between the COUNTY OF COLUMBUS, a body politic formed under and existing by virtue of the General Statutes of North Carolina, sometimes hereinafter referred to as the "County" and DAVID G. BUNN AND ASSOCIATES OF CAROLINA OB/GYN OF Wilmington, North Carolina, a professional association duly organized and existing under and by virtue of the corporation laws of the State of North Carolina and the Board of Medical Examiners of the said State, sometimes hereinafter referred to as the "Doctors";

## W I T N E S S E T H :

**WHEREAS,** the County of Columbus is presently in need of employing the services of an OB/GYN Physician in order to provide better medical services for the treatment of patients and patrons of the Columbus County Health Department; and

**WHEREAS,** pursuant to Chapter 153-A, the County of Columbus may provide for and regulate public health pursuant to Chapter 130 of the North Carolina General Statutes and any other authorized activity of the public health; and

**WHEREAS,** the Board of County Commissioners of Columbus County and the Columbus County Board of Health are now in agreement that a duly licensed OB/GYN Physician as defined by the North Carolina Board of Medical Examiners, must be employed and retained by the said county to assist the Columbus County Public Health Department in prenatal, perinatal, and family planning services;

**BE IT THEREFORE AGREED AND CONTRACTED** as follows:

1. That David G. Bunn, M.D. and Associates of Carolina OB/GYN of Wilmington, North Carolina do hereby agree on a weekly basis to furnish a total of eight (8) hours per week work in the clinics which are scheduled by the Columbus County Board of Health and two (2) hours per week commuting to and from Wilmington for a total of ten (10) hours per week. In exchange for the said services rendered, the said David G. Bunn and Associates of Carolina OB/GYN of Wilmington, North Carolina shall be paid at the rate of Sixty (\$60.00) Dollars per hour in monthly installments upon submission of signed time sheets by the physician rendering the said services. The total sum due for any week shall not exceed the sum of Six Hundred (\$600.00) Dollars or Sixty (\$60.00) Dollars per hour whichever is less. If for any reason the physicians are unable to provide the services during any given week, then no payment shall be forthcoming for said services not rendered. It is understood and agreed that each hour shall be accurately kept by the said physician and the Columbus County Health Department.

2. That the dates of employment by the county for each week are hereby not specifically set forth and are to be mutually agreed upon by the Columbus County Public Health Department and David G. Bunn and Associates of Carolina OB/GYN of Wilmington, North Carolina.

3. The said David G. Bunn and Associates of Wilmington, North Carolina are totally responsible for their conduct, performance of duty and professional decisions while employed at the Columbus County Public Health Department and they hereby stipulate and agree that they are independent contractors and not employees of the said Columbus County Public Health Department, Columbus County Board of Health of Columbus County. The said David G. Bunn and Associates of Carolina OB/GYN further hereby stipulate, contract and agree that it shall obtain and keep in full force and effect a professional liability insurance policy in a sum of no less than One Million (\$1,000,000.00) Dollars for the duration of this contract.

4. In any case where David G. Bunn, M. D. or his associate cannot attend a previously scheduled clinic, advance notice must be given to the Public Health Director or the Director of Nurses and every effort must be made by the said David G. Bunn and Associates of Carolina OB/GYN to obtain the services of a qualified physician who is acceptable to the Columbus County Public Health Director and whose payment will be made according to the schedule set forth above. Columbus County hereby agrees that the said payment for any substitute position shall be charged the same as if David G. Bunn and Associates of Carolina OB/GYN of Wilmington performed the said services and that payment shall be made to the said David G. Bunn Associates of Carolina OB/GYN directly and it shall be David G. Bunn's responsibility for payment of the substitute physician.

5. Each party to this contract agrees and stipulates that either party may declare this contract to be null and void upon the giving of no less than sixty (60) days prior notice. This contract shall be null and void and shall terminate automatically upon July 1, 1991, the beginning of the new fiscal year for the county. This contract may be extended if agreeable to both parties hereto.

6. All checks should be made payable to Carolina OB/GYN of Wilmington, North Carolina, and it is agreed and stipulated that the said checks shall be mailed in the ordinary course of business to the said doctor at the following address of 2215 Canterwood Drive, Wilmington, North Carolina 28401.

7. The effective date of this contract is July 1, 1990.

**APPOINTMENT - COMMISSIONER WORLEY'S REGISNATION FROM FOUR COUNTY**

ROAD NAMES - GENERAL STATUTES TO PROTECT AND FINE FOR DESTRUCTION OF PUBLIC PROPERTY

The Chairman reported that Columbus County road signs have been vandalized by being torn down, cut with tin snips and spray painted and asked the County Attorney if the N.C. General Statutes addresses vandalism or if the Board needs to set a policy to deal with the problem.

The County Attorney stated that there are two General Statutes that addresses vandalism. They are as follows:

G.S. 14-127. Willful and Wanton Injury to Real Property.

If any person shall willfully and wantonly damage, injure or destroy any real property whatsoever, either of a public or private nature, he shall be guilty of a misdemeanor and shall be punished by fine or imprisonment or both, in the discretion of the court.

G.S. 14-147. Removing, Altering or Defacing Landmarks.

If any person, firm or corporation shall knowingly remove, alter or deface any landmark in anywise whatsoever, or shall knowingly cause such removal, alteration or defacement to be done, such person, firm or corporation shall be guilty of a misdemeanor.

The Board requested Sheriff Harold Rains to look into the vandalism and enforce the General Statutes as mentioned. The Sheriff assured the Board of Commissioners that deputies will be alerted to the problem, and they will be on the lookout for perpetrators.

COLUMBUS COUNTY CENSUS - CHALLENGE THE 1990 FIGURES

There was a general discussion on the 1990 Census calculations for Columbus County being decreased by approximately 3,000 for 1990.

The Board directed the County Administrator to go through the necessary channels to challenge the 1990 Census Bureau figures for Columbus County.
