One Million, Five Hundred Thousand Dollars and requested the Board's approval.

Koonce and passed unanimously to approve the 1989 Columbus County Hospital audit report as presented by Mr. Rogers and S. Preston Douglas & Associates, Certified Public Accountants.

THAT WHEREAS, the County of Columbus provides a Sanitary Landfill for use by the citizens of Columbus County; and

WHEREAS, the County of Columbus has the responsibility to provide the service of disposal of Columbus County Solid Waste; and

WHEREAS, all North Carolina Landfills are permitted, regulated and monitored by inspection by the North Carolina Department of Human Resources, Division of Health Services; and

WHEREAS, the 1989 General Assembly of North Carolina enacted Senate Bill III, Chapter 784, which is titled "An Act to Improve the Management of Solid Waste", which was ratified August 12, 1989; and

WHEREAS, Senate Bill III represents a significant change in State Policy of Solid Waste Management and Disposal; and

WHEREAS, Senate Bill III has an implementation schedule and said schedule prohibits the burial of whole tires effective March 1, 1990; and

WHEREAS, this mandate has directly increased the County's cost for scrap tire disposal; and

WHEREAS, the Columbus County Board of Commissioners has determined that it is necessary to establish a fee schedule for scrap tire disposal in the Columbus County Landfill in accordance with the provision of Senate Bill III. NOW, THEREFORE, BE IT RESOLVED by the Columbus County Board of Commissioners, that the following Fee Schedule will be adopted and implemented on September 17, 1990 by Columbus County for scrap tire disposal at the Columbus County Landfill:

### SCRAP TIRE DISPOSAL FEES

\$ .75 each, car and light truck - up to 16.5 rim \$2.00 each, medium and large truck - over 16.5 rim \$5.00 each, farm tractor type \$ \_\_\_\_\_ each, heavy equipment, logging, skidder type. Duly adopted this 1st day of October, 1990.

# SOLID WASTE - RESOLUTION IN REDUCTION

#### RESOLUTION

WHEREAS, the problem of solid wste disposal has reached a near crisis stage at local, state, and national levels; and

WHEREAS, all levels of local government are charged with the task of collecting and disposing of said waste in a safe and environmentally sound system; and

WHEREAS, the disposal of said waste is becoming more difficult annually due to the collection costs, disposal site operating costs; and

WHEREAS, the state is mandating that local governments reduce the volume of waste by recycling and/or other methods; and

WHEREAS, the market is limited for the intake of massive volumes of recycled waste materials such as automotive tires, plastic bottles, certain paper products, styrofoam, etc.

NOW, THEREFORE, BE IT RESOLVED, that the Columbus County Board of Commissioners respectfully requests that avenues of reducing the waste stream at its source be given adequate consideration at the next session of the Legislature. Such consideration may include, but not be limited to, the sale of liquids (including all soft drinks, beer, etc.) in returnable glass bottles and that all commercial establishments selling said product be required to return to the person returning the container any deposit paid whether or not the product was purchased at that place of business, that contractors paid for surfacing roads be required to use tires in its paving or resurfacing contracts, that businesses using reclaimed paper products be given tax incentives, and that products whose disposal may have long term negative environmental impact such as certain plastics and styrofoam use be limited.
