ECONOMIC DEVELOPMENT DIRECTOR - INTRODUCTION & WELCOME

Chairman Norris introduced William Lee Smith, the Economic Development Director, who became employed with the County on January 3, 1991 and welcomed him and his family to Columbus County.

PUBLIC HEARING - COUNTY-WIDE HOUSING AUTHORITY

A motion was made by Commissioner Worley, seconded by Commissioner Richardson and passed unaniously to call a public hearing for the purpose of the creation of a County-wide Housing Authority for Columbus County.

Haynes Graham, representing the Waccamaw Siouan Development Association, explained the advantages of a County Housing Authority and requested the Board adopt a Resolution endorsing a County-wide Housing Authority and allow WSDA to form and administer the Housing Program.

The Chairman requested anyone in attendance to speak in favor of or against the creation of a County-wide Housing Authority for Columbus County.

Several of the Board members directed questions to Mr. Graham and also Emory Worley questioned Mr. Graham.

There being no further comments, a motion was made by Commissioner Dew, seconded by Commissioner Worley and passed unanimously to close the public hearing.

HOUSING - COMMITTEE TO BE APPOINTED

A motion was made by Commissioner Koonce, seconded by Commissioner Worley and passed unanimously to appoint a County-wide Housing Authority Committee consisting of ten members to do a study on the issue and prepare a budget for the County-wide Housing Authority and present to the Board of Commissioners for consideration. The Committee will consist of two members from each Board member's respective zone.

BUDGET AMENDMENT - HEALTH DEPT.

A motion was made by Commissioner Dew, seconded by Commissioner Richardson and passed unanimously to approve a budget amendment for the Health Department as follows:

ANIMAL CONTROL - ORDINANCE TABLED

Carl Herring, Animal Control Officer and Marian Duncan, Health Director requested the Board's consideration in adopting the proposed Animal Control Ordinance.

A motion was made by Commissioner Dew, seconded by Commissioner Koonce and passed unanimously to table the Ordinance until several items questioned by the Board can be redrafted by the Ordinance Committee, and James E. Hill, Jr., County Attorney, and present back to the Board for consideration.

FIRE MARSHAL - 1989-90 PROGRESS REPORT

Jimmy Jackson, Columbus County Fire Marshal, gave a progress report for 1989-90 stating that there were 704 fires in 1989 and 574 fires in 1990. The County now has Automatic Mutual Aid which should help reduce insurance rates in the County.

FIRE & RESCUE - REQUEST TO REOPEN PENSION FUND TO VOLUNTEERS

Commissioner Ed Worley questioned Jimmy Jackson about the State Firemen's and Rescue Squad Workers' Pension Fund that will allow qualified members to purchase prior service.

Jimmy Jackson, Fire Marshal, explained that the pension fund was closed effective March 31, 1987 and it will take an act of legislature to get the fund reopened for new members.

A motion was made by Commissioner Worley, seconded by Commissioner Dew and passed unanimously to direct the Administrative office to write letters to Senator R. C. Soles, Jr. and Representative Leo Mercer and request that they present this issue to the N.C. General Assembly for consideration of reopening the Pension Fund.

EMERGENCY MANAGEMENT - REPORT ON 911 SYSTEM

John H. Moore, Jr., Emergency Management Coordinator, presented the Board with an update on the 911 emergency telephone service for the County stating that a meeting is scheduled the latter part of the week to meet with all four (4) telephone companies who provide services for Columbus County.

Commissioner Koonce requested that Mr. Moore investigate the possibility of countywide toll free phone service.

EMERGENCY MANAGEMENT - COMMUNICATIONS EVALUATION

Roy L. Lowe, County Administrator, presented the Board with an evaluation of the overall County communications from Piedmont Communications, Fayetteville, N.C. and they have presented an estimate of \$3,371.50 to replace the antenna and coax cable and raise the antenna twenty feet.

The Board concurred to direct the Administrator to receive another bid and present both bids at the next Board meeting.

TAX - WAIVE TAX PENALITY FOR COCA COLA DENIED

Roy L. Lowe, County Administrator and William D. Brooks, Tax Administrator, requested direction from the Board concerning the recent request from Coca Cola Bottling, Incorporated to waive the tax penalty on discoveries that were made on vending machines located in the county that were not listed. Mr. Brooks stated that there have been several discoveries made throughout the County with no waiver of penalities.

A motion was made by Commissioner Koonce, seconded by Commissioner Dew and passed unanimously to deny the request to waive penalities with the stipulation that the penalities end on the day that the request was made by Coca Cola Bottling Company.

AGRICULTURE EXTENSION - APPROVAL OF 4-H FUND BANK ACCOUNT

A motion was made by Commissioner Worley, seconded by Commissioner Richardson and passed unanimously to designate the Agriculture Extension 4-H Agent, William E. Triplett, to maintain a bank account for the 4-H Club with the Finance Officer, Gayle Godwin also having signatory authority. Resolution is on file in the office on the Clerk to the Board.

LOWER CAPE FEAR WATER & SEWER - REQUEST FOR ADDITIONAL FUNDS FOR INTER-BASIN TRANSFER

The Administrator presented a bill from the Lower Cape Fear Water and Sewer Authority requesting the County make an additional payment of \$3,653.29 in reference to legal cost in the interbasin transfer litigation.

The Board reached a general consensus to table the request for additional funding until the Administrator can obtain more information concerning the interbasin water transfer legal fees.

RAPE CRISIS - REQUEST FOR FUNDING DENIED

The Administrator presented a request from Angelia Rhodes, representing Rape Crisis, in the amount of \$5,000.00 for financial support of the Domestic Violence volunteer work in Columbus County.

A motion was made by Commissioner Dew, seconded by Commissioner Koonce and passed unanimously to deny the request as this is a state funded program.
