Ms. Carroll also invited the Commissioners to attend the ARC Annual Picnic, to be held May 15 1991 at Lake Waccamaw, N.C.

1990-91 OPERATING BUDGET - COUNTY BUSINESS TRAVEL

A motion was made by Commissioner Koonce, seconded by Commissioner Richardson and passed unanimously to curtail all county travel immediately with the exception of the day to day travel necessary in carrying out the functions of each department within the County. Any travel outside the County is to be approved by Chairman Lynwood Norris and Administrator Roy L. Lowe.

INTERAGENCY TRANSPORTATION - REQUEST & APPROVAL FOR ADDITIONAL FUNDING

Davis Godwin, Interagency Transportation Director, requested the Board to consider funding the Interagency Transportation Handicapped Program for the months of April, May, and June, 1991 in the amount of \$16,500.

motion was made by Commissioner Worley, seconded by Commissioner Dew

and passed unanimously to fund the Sheltered Workshop Transportation Program up to \$5,200 per month through June 30, 1991. Further, amend the budget by appropriating funds from Non-Departmental - Contingencies (10-660-9999) in the amount of \$15,600.00 to be expended in Special Apropriations - Sheltered Workshop Transportation (10-690-9502).

COUNTY BUILDINGS - CONCERNED CITIZEN COMMENTS

Dial Gray, Jr., a concerned citizen, addressed the Board in reference to the construction of a social services building requesting how much space will be needed and parking facilities. Mr. Gray questioned the Board if a study has been done to consider the possibility of renovating existing buildings to accomodate the county building needs that would possibly minimize the cost instead of constructing a new building.

The Chairman informed Mr. Gray that the County has only interviewed Architectural Firms to consider drawing up a master plan for the approximately 55 acres that was purchased in 1990 North of Whiteville and at such time that constructing a building is considered, every feasible possibility will be explored and considered.

HOSPITAL (NEW HANOVER) - BOARD ENDORSES REHAB CENTER

David Plate, president of the New Hanover Regional Medical Center requested the Commissioners endorsement on a 45-bed rehabilitation hospital, stating that the closest rehab hospital to Columbus County is Fayetteville, NC.

A motion was made by Commissioner Koonce, seconded by Commissioner Dew and passed unanimously to draft a "Resolution of Support" for the New Hanover Regional Medical Center's application for a 45-bed rehabilitation hospital contingent upon the approval of the Columbus County Hospital Board of Trustees.

Mr. Slate advised the Board that he has met with Mr. Ralph Rogers, Columbus County Hospital Administrator, and the Hospital Board endorses the application.
