BE IT FURTHER RESOLVED, that Columbus County will administer this loan in accordance with the rules and regulations of the Department of Economic and Community Development.

BE IT FURTHER RESOLVED, the County will administer the loan through the County Finance Office or chosen financial institution.

BE IT FURTHER RESOLVED, that the loan will be monitored quarterly to assure compliance with this proposal and with the Department of Economic and Community Development regulations. Also, creation of new jobs will be monitored in accordance with regulations of the Department of Economic and Community Development.

BE IT FURTHER RESOLVED, that Top Tobacco Company, will create 186 new jobs in a period of three years, from January 1, 1993 to January 1, 1996.

BE IT FURTHER RESOLVED, that in accordance with the creation of 186 jobs, the amount of the loan application will be \$223,200.00.
