BOARD OF ELECTIONS - REQUEST FOR VOTING MACHINES

Frank Stanley, Edward Ulrich, and Bobby Sessions, Columbus County Board of Election Members, addressed the Board on the voting equipment needs for Columbus County. The voting machine problems exist due to the result of redistricting in Columbus County. There will be approximately 72 combinations for the fall election; therefore, we will need 72 counters and 72 boxes. Cost of new machines range from \$153,000 to \$177,000; however, a lease/purchase agreement could be used.

Commissioners Koonce and Richardson and County Administrator Lowe stated they were told that at the National Association of County Commissioners meeting in Minneapolis, Minnesota that the presently owned vote-counting machines could be programmed to count split precincts.

The Board of Commissioners concurred to instruct the County Administrator to contact the firm that presented this information to them and prove to the Board of Elections that the machines will work.

There was a lengthy discussion between the Board of Commissioners and the Board of Elections.

Hill, Jr., County Attorney, to prepare the bid for advertising the purchasing, lease/purchase, long-term maintenance, and the life expectancy of the new vote-counting machines.

TAX DEPARTMENT - INSOLVENT TAX LIST APPROVED

Ida McPherson, represented Bill Brooks, Tax Administrator, stated that certain personal property taxes levied for the years 1982, 1983, 1984, 1985, 1986, 1987, 1988, 1989 and 1990 remain uncollected. Said taxes are not liens upon real estate.
