There were approximately forty (40) persons in attendance.

A motion was made by Commissioner Norris, seconded by Commissioner Richardson and passed unanimously to enter into a public hearing for the purpose of citizens' input on the establishment of a county-wide 9-1-1 Emergency Telephone System.

Chairman Worley then turned the meeting over to John Moore, Emergency Management Coordinator, who explained the basic 911 system which enables you to dial three (3) digits instead of seven (7) digits. The enhanced 911 system enables the dispatcher to have vital information displayed on a computer screen. Once 911 digits are dialed, the dispatcher would know the address, location and name of the phone customer where the call was made from.

Chairman Worley requested anyone in attendance who wished to ask questions or make comments to be recognized by raising their hand and stating their name.

GOVERNING BODY - BOARD MEETING MOVED TO COURTHOUSE SUPERIOR COURTROOM

Due to the large number of persons attending the Board meeting (approximately 75), a motion was made by Commissioner Norris, seconded by Commissioner Koonce and passed unanimously to move the Board meeting to the Columbus County Courthouse Superior Courtroom.

Chairman Worley called the meeting to order and the Reverend Moore gave the invocation.

SOIL CONSERVATION - WASTE MANAGEMENT SYSTEM UPDATE

Brack Williams, Soil Conservation Director, updated the Board on the total waste management system that the Soil Conservation provides in Columbus County. Mr. Williams presented the Board with design criteria for waste treatment lagoons, waste production and land application of swine anaerobic lagoon liquid. Soil Conservation Board members Gilbert Anderson, Chairman, Bill Freidman, Bobby Moore, Ralph Spivey, and James W. Gore were present and stated they pledge their cooperation to Columbus County in studying the livestock industry.

HOG PRODUCTION - RANSOM TOWNSHIP CONCERNED CITIZENS REQUEST MORATORIUM

Christine Hall, spokesperson for the Ransom Township Concerned Citizens, presented a petition of 518 signatures who are requesting the following:

We the concerned citizens of Columbus County, respectfully request the Columbus County Commissioners to place a moratorium on the construction and operation of any hog operation facility until the county can research the environmental and social affects of these operations of the community and county. Since the state does not have any tested empirical data on the long term affects of the operations, we recommend the moratorium not be less than one year. We further

request the commissioners to immediately begin setting strict regulations and guidelines on the construction, location, and monitoring of these facilities. We request that no operation be less than one mile from a dwelling, church, or business.

The following information was requested by the Ransom Township Concerned Citizens:

1. A copy of the letter written to the Legislative representatives and their response that the Board approved to be written at the September 8, 1992 meeting.
2. Names of the Committee that were to be appointed by the County Commissioners, their duties and responsibilities and requested that Perry Dixon be appointed to the Committee.
3. What recommendations were given to the Owens' family Operation on Highway 87 by the Soil Conservation and the Environmental Department and have they been carried out.

The Chairman stated that the above concerns will be explored and the Administrator will give a report to the Concerned Citizens. The Citizens' Livestock Advisory Committee will be appointed at this meeting.

CONTRACT & AGREEMENT - COLUMBUS COUNTY MEDAC TRANSPORTATION, INC.

A motion was made by Commissioner Richardson, seconded by Commissioner Norris and passed unanimously to approve the following Contract and Agreement between the County of Columbus and Columbus County MEDAC Transport, Inc.

STATE OF NORTH CAROLINA

COLUMBUS COUNTY

CONTRACT AND AGREEMENT

THIS CONTRACT AND AGREEMENT, made and entered into this 21st day of September, 1992, by and between the COUNTY OF COLUMBUS, a body politic under the General Statutes of the State of North Carolina and sometimes hereinafter referred to as the party of the first part or the said "County", and COLUMBUS COUNTY MEDAC TRANSPORT, INC., a North Carolina Corporation and sometimes hereinafter referred to as the party of the second part and/or the said "Service";

W I T N E S S E T H :

WHEREAS, the General Statutes of the State of North Carolina provide that the County is authorized to enter into a contract for certain services with an ambulance operator who shall remain on call for the transportation of indigent citizens of the said County or persons serviced by the County Department of Social Services as public assistance recipients; and

WHEREAS, the County of Columbus is further authorized by the General Statutes of North Carolina to contract for ambulance services in any and all portions of the said county; and

WHEREAS, the County Commissioners of Columbus County, North Carolina are cognizant of the fact that the citizens and residents of the said County are in need of additional transportation to various medical institutions and hospitals throughout the Southeastern United States for their own personal individual health and well being; and

WHEREAS, numerous rescue squad members of various rescue squads located throughout Columbus County have stated publicly that individual transportation beyond the Columbus County Hospital, Inc. in Whiteville, North Carolina sometimes works an extreme personal hardship on their lives and is certainly needed by many patients whom they transport to the Columbus County Hospital, Inc.

IT IS THEREFORE, RESOLVED AND AGREED AND CONTRACTED by and between the party of the first part and the party of the second part and for the mutual promises of an agreement herein contained and pursuant to the general powers and authorities of the party of the second part to furnish the said ambulance services to the citizens and residents of the County of Columbus that the party of the first part and the party of the second part mutually covenant, agree and contract as follows:

(1) The party of the second part shall receive from the party of the first part, the sum of SEVEN THOUSAND (\$7,000.00) DOLLARS annually for transportation of all indigent citizens and residents of Columbus County from Columbus County from Columbus County Hospital, Inc. to various other medical locations. This payment shall be made in equal monthly installments of Five Hundred Eighty Three and 33/100 (\$583.33) Dollars per month, beginning on the first day of each successive calendar month thereafter.

(2) The party of the first part shall be liable for no more than SEVEN THOUSAND (\$7,000.00) DOLLARS per year for a total amount of the transportation of all indigent citizens and residents of Columbus County by the party of the second part throughout the life of the contract.

(3) The party of the first part and the party of the second part agree that the life of this contract shall begin on October 1, 1992 and continue until the 30th day of September, 1993, and shall be automatically renewed unless terminated by paragraph 6 herein.

(4) The party of the second part shall provide and will maintain and equip all ambulances with the minimum equipment as provided by and according to the Department of Human Resources, E.M.S. Office at Raleigh, North Carolina, and any and all federal agencies which may be applicable; the said party of the second part will maintain an ambulance ready to go at their normal place of business upon receiving a call from the Columbus County Hospital, Inc. for transportation of any and all patients and citizens of Columbus County, North Carolina whether the same be indigent or fee paying; and that the responsibility of payment of all employees as provided by statute or as set forth by the E.M.S. of the Department of Human Resources or any and all federal agencies shall be that of the party of the second part and the party of the first part shall have no additional financial obligations beyond the sums as above stated and at no time an excess of SEVEN THOUSAND (\$7,000.00) DOLLARS per year, unless otherwise agreed upon by the parties hereto and

budgeted in the duly adopted budget of Columbus County. The party of the first part is cognizant of the fact that when the party of the second part is in operation in the transportation of a patient from one medical facility to another that the ambulance shall not be available in Columbus County, North Carolina, and that if any other contract is made between any organization or person, it shall be the responsibility of that organization or person to provide a back up to the party of the second part as set forth and agreed upon by the Columbus County Hospital, Inc. Administration and the Board of Commissioners of Columbus County. The party of the second part recognizes that they are on call at all times and that the Columbus County Hospital, Inc. shall alternate among the various contracting agencies and each contracting agency agrees to notify all other contracting agencies when the other contracting agency is on a private call or run. The party of the second part recognizes their responsibility to return the ambulance as expeditiously as possible and in addition thereto covenants with the party of the first part that the same shall be returned to Columbus County in order to provide the services for the citizens and residents of the said County as fast and as steady as humanly possible.

(5) That the party of the second part agrees to supply to the party of the first part monthly a detailed list of all names and addresses of all non-payment recipients who are transported by the party of the second part on the standard medicare forms. That in addition thereto the party of the second part agrees to provide the number of all paying clients, non-paying clients, medicaid clients and medicare clients on a monthly basis to the Columbus County Administrator, Columbus County Administration Building, 111 Washington Street, Whiteville, North Carolina.

(6) The party of the first part and the party of the second part hereby agree that this contract shall automatically be renewable without notice and that the same may be broken by either of the parties hereto upon the giving of sixty (60) days prior notice to the date of the termination of this contract or the anniversary date of this contract, provided that the same is acceptable by and to the other party.
