Chairman Koonce called the meeting to order and Reverend Wade Fowler, gave the invocation.

BOARD MINUTES APPROVAL

A motion was made by Commissioner Richardson, seconded by Commissioner Williams and passed unanimously to approve the minutes of the September 20, 1993 Board meeting, as recorded.

RESOLUTION - SUPPORT OF I-73

A motion was made by Commissioner Williams, seconded by Commissioner Norris and passed unanimously to adopt the following Resolution:

RESOLUTION CONCERNING PROPOSED INTERSTATE 73

WHEREAS, on or about December 18, 1991 Congress mandated a Federal Interstate to be known as Interstate 73 to commence in Detroit, Michigan and to terminate at Charleston, South Carolina; and

WHEREAS, the route was proposed to pass through West Virginia, through Winston-Salem, North Carolina, West of Fayetteville, and terminate in Charleston, South Carolina, but with the exact route not mandated; and

WHEREAS, there is some evidence that a later amendment

required that the proposed Interstate 73, while terminating in Charleston, South Carolina, would pass through or near Myrtle Beach, South Carolina; and

WHEREAS, a final decision as to the proposed route is to be made on or before December 18, 1993; and

WHEREAS, the North Carolina Department of Transportation in May, 1993, approved a proposed corridor which would enter North Carolina just west of Mount Airy and follow existing routes which meet Interstate standards with the corridor proceeding from Asheboro, North Carolina along 220 to Rockingham; and

WHEREAS, the North Carolina Department of Transportation has indicated, at a hearing in Columbus County on September 21, 1993, at Southeastern Community College attended by business and political leaders from Robeson, Columbus, New Hanover and Brunswick Counties that it is reconsidering the Route which proposed Interstate 73 would follow from Rockingham, North Carolina prior to entering the State of South Carolina; and

WHEREAS, indications are that if the Route entered South Carolina directly southwest of Rockingham, that it would proceed to Florence, South Carolina, which is already served by Interstate 20 and Interstate 95 and proceed thence to Charleston, South Carolina, which is already served by Interstate 77 and Interstate 26; and

WHEREAS, U.S. Highway 74 leading eastward from Rockingham, North Carolina, just north of the North Carolina—South Carolina state line to Wilmington is upgraded in part to Interstate standards and is scheduled to be completely upgraded to Interstate standards during or before 1996; and

WHEREAS, U.S. Highway 74 passes through a series of counties, including Scotland, Robeson, Columbus and Brunswick in southeastern North Carolina which are economically deprived but which have great economic potential; and

WHEREAS, U.S. Highway 74 terminates in New Hanover County, North Carolina, which has exceptional beaches, a historic downtown, outlying point of historic interests and North Carolina's major

port; and

WHEREAS, North Carolina has never provided adequate access from the major manufacturing centers in the Piedmont to the port at Wilmington; and

WHEREAS, the Brunswick County beaches would greatly benefit from improved access from the Midwestern states of our great nation and from the Piedmont of our state; and

WHEREAS, commerce and trade increase in Scotland, Robeson, Columbus, Brunswick and New Hanover Counties when routes from east to west and from west to east are improved; and

WHEREAS, Columbus County is developing an industrial park just east of Southeastern Community College and adjacent to U.S. Highway 74-76 which Columbus County hopes will become a Southeastern regional business park; and

WHEREAS, at the meeting of regional counties held at Southeastern Community College on September 21, 1993, the consensus was that the Interstate 73 corridor should follow U.S. Highway 74 from Rockingham and east to a point east of Chadbourn and west of Whiteville near Southeastern Community College and the proposed business and industrial park;

NOW, THEREFORE, BE IT RESOLVED THAT

- 1. The North Carolina Department of Transportation recommends that the I-73 corridor follow a route from near Mount Airy, North Carolina to Rockingham, North Carolina, and that the corridor then proceed along U.S. Highway 74 to a point adjacent to Southeastern Community College and the proposed Southeastern Regional Business Park;
- 2. That the Interstate 73 corridor then cross the Southeastern Regional Business Park and follow a route which would be the shortest and most direct route along Highways 410 and 701 to the intersection of 701 and South Carolina Highway 9;
- 3. That the corridor then follow such route as would be favored by the State of South Carolina as it provides very much needed access to North Myrtle Beach and Myrtle Beach, and thence to Charleston, South Carolina;

- 4. That U.S. 74 be upgraded to Interstate standards from Southeastern Community College and the Southeastern Regional Business Park to Wilmington where it would serve not only the New Hanover Beaches and historic areas but also the port of Wilmington which is so vital to the economic progress of Southeastern North Carolina and where it would interact with U.S. Highway 17 which has been greatly improved and which is slated for significant additional improvements;
- 5. That North Carolina Highways 904, 130, 410, 211, 87 and other such highways which provide access to the New Hanover and Brunswick County Beaches be upgraded; and
- 6. That a copy of this Resolution be forwarded to the Honorable James B. Hunt, Governor, the Honorable Sam Hunt, Secretary of the North Carolina Department of Transportation; the Honorable Charlie Rose, United States Congressman, and to Mr. Lyndo Tippett, Mr. David Green and Mr. Odell Williamson, regional members of the North Carolina Board of Transportation.
