LIVESTOCK OPERATIONS - CONCERNED CITIZENS FROM ST. JAMES AREA

The Reverend Ronald Campbell, spokesperson for approximately thirty-five (35) St. James residents who were in attendance, stated that they are opposed to plans by the Lundy Company to build a large swine operation off SR 1713, White Hall Road. Reverend Campbell stated that the operation would affect the Union Baptist Church and residents feared problems from potential odors, insects and water pollution and asked the Commissioners to seriously consider the need for stricter controls on large-scale swine farms.

Oscar Blanks, a concerned citizen, stated that the large hog operations are unwholesome, unhealthy, offensive and serve only the needs of the greedy.

Haynes Graham, a concerned citizen, suggested the Board consider the following items in regards to pig operations:

- Write all major producers saying the county does not want big swine operations near populated communities;
- 2. Set up a procedure for county permits for swine operations; and
- Write legislators asking for rules on planning and construction of large swine operations.

There was a question and answer session from the concerned citizens to the Board of Commissioners.

Dempsey B. Herring, Interim County Administrator, informed the group that letters have been sent to the major swine integraters in Columbus County asking them what their future plans are in regards to expanding swine operations. Three companies said they would meet with the Board of Commissioners and one said it plans no expansions here.

Mr. Herring urged the residents to take their complaint

directly to Lundy in Clinton and to appear at upcoming hearings of the state study group.

A motion was made by Commissioner Dutton, seconded by Commissioner Norris and passed unanimously to direct Administration to contact the various integraters and follow-up with what their intentions are.

A motion was made by Commissioner Gray, seconded by Commissioner Dutton and passed unanimously to direct Administration to charter up to two (2) buses, at the County's expense, to transport concerned citizens of the St. James area to the Lundy plant in Clinton, N.C. to make them aware of their concerns.

WACCAMAW RIVER - REQUEST REPEALING HB 876

Dempsey B. Herring, Interim County Administrator, commented on House Bill 876 which was introduced in 1993 by Representative David Redwine to have a certain section of the Waccamaw River posted as a "No Wake" zone by using floating buoys. The bill creates a hardship on the County since it designates only Columbus County to be responsible for marking the river with buoys. Mr. Herring requested the Board to request legislation to amend HB 876 to address changing the buoys to signs and to have Brunswick County, as well as Columbus County, responsible for such signage.

A motion was made by Commissioner Norris, seconded by Commissioner Britt and passed unanimously to request House Bill 876 amended to address changing the buoys to signs and to have Brunswick County, as well as Columbus County, responsible for the signage for identifying the "No Wake" zone, with both counties sharing the cost.

SHERIFF - REQUEST FOR EMPLOYEE AND COMPUTERIZATION TABLED

The Board concurred to table the request from Sheriff Jimmy P. Ferguson for a new position and additional computerization due to new laws that affect the Sheriff's Department due to Sheriff Ferguson's absence from the meeting.

FIRE & RESCUE - APPROVAL OF EXTENSION OF COLE'S FIRE, AMBULANCE AND RESCUE SERVICE DISTRICT

A motion was made by Commissioner Norris, seconded by Commissioner Wilson and passed unanimously to approve the extension

to the service district known as Cole's Fire, Ambulance, and Rescue District to provide fire protection and emergency medical service to an area outside of the town limits of Fair Bluff and to approve the present tax rate of \$0.10 per \$100.00 property evaluation for the service district extension.

FIRE & RESCUE - APPROVAL OF MAP & DESCRIPTION FOR COLE'S FIRE INSURANCE DISTRICT

A motion was made by Commissioner Norris, seconded by Commissioner Britt and passed unanimously to approve the map and description for Cole's Fire Insurance District as approved by the N. C. Department of Insurance Fire and Rescue Service Division. A map and description of the district is on file in the office of the Clerk to the Board and the County Fire Marshal.

FIRE & RESCUE - APPROVAL OF MAP & DESCRIPTION FOR CLARKTON RURAL FIRE INSURANCE DISTRICT

A motion was made by Commissioner Wilson, seconded by Commissioner Dutton and passed unanimously to approve the map and description for Clarkton Rural Fire Insurance District as approved by the N. C. Department of Insurance Fire and Rescue Service Division. A map and description of the district is on file in the office of the Clerk to the Board and the County Fire Marshal.

SOIL & WATER CONSERVATION - APPLICANT FOR TESTING TO BE INTERVIEWED 11-7-95

Dempsey B. Herring, Interim Administrator, reported to the Board that the Soil & Water Conservation Board of Directors will begin interviewing applicants that were initially taken for the position of Soil and Water Conservation Water Testing Technician on November 7, 1995 that was approved by the state and the County to be cost-shared equally.
