ORDER AUTHORIZING \$6,500,000 WATER BONDS

WHEREAS, pursuant to Article 6 of Chapter 162A of the General Statutes of North Carolina, the Columbus County Water and Sewer District II, in Columbus County, North Carolina, was duly created for the purpose of providing water service to the residents of the territory included within said District and vested with the powers set forth in said Article 6; and

;

WHEREAS, the Board of Commissioners for the County of Columbus, North Carolina has found that there is a demonstrable need for providing water service in said District; and

WHEREAS, pursuant to said Article 6, said Board is the Governing Body of said District; now, therefore,

BE IT ORDERED by the Board of Commissioners for the County of Columbus, as the Governing Body of the Columbus County Water and Sewer District II, in Columbus County, North Carolina:

1. That, pursuant to Article 6 of Chapter 162A of the General Statutes of North Carolina and The Local Government Bond Act, as amended, the Columbus County Water and Sewer District II, in Columbus County, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said District may now or hereafter have power or authority to contract, and in evidence thereof to issue Water Bonds in an aggregate principal amount not exceeding \$6,500,000 for the purpose of providing funds, with any other available funds, for constructing a water system of said District, within and without the corporate limits of said District, including the construction and installation of wells, water treatment facilities, elevated water storage tanks, water mains and lines and appurtenant facilities, and the acquisition of necessary land, rights-of way, and equipment.

2. That taxes shall be levied in said District in an amount sufficient to pay the principal of and the interest on said bonds.

3. That a sworn statement of the debt of said District has been filed with the Clerk to said Board and is open to public inspection.

4. That this Order shall take effect when approved by the voters of said District at a referendum as provided in the Local Government Bond Act, as amended.

The Board of Commissioners thereupon designated the Finance Officer of the County as the officer whose duty it shall be to make and file with the Clerk to the Board of Commissioners the Sworn Statement of Debt of the District which is required by The Local Government Bond Act, as amended, to be filed after the bond order has been introduced and before the public hearing thereon.

Thereupon, the Finance Officer filed with the Clerk to the Board of Commissioners, in the presence of the Board of Commissioners, the Sworn Statement of Debt as so required.

Thereupon the order entitled: "ORDER AUTHORIZING \$6,500,000 WATER BONDS" was passed on first reading.
