SOLID WASTE - LANDFILL CLOSURE COSTS

Dempsey B. Herring, County Administrator, reported that William W. Dreitzler from Marlowe, Drietzler and Associates, has advised the County the landfill closure may cost more than \$1.5 million dollars. The estimated cost for closing the Landfill in 1994 was \$711,590.

Mr. Herring reported the interpretation of state environmental regulations on closing landfills has caused the higher cost.

SOLID WASTE - OPPOSITION TO REGULATIONS BEING IMPOSED AFTER ADOPTION OF ENVIRONMENTAL SOLID WASTE PLANS RESOLUTION

A motion was made by Commissioner Wilson, seconded by Commissioner Britt and passed unanimously to adopt the following Resolution.

OPPOSITION to REGULATIONS
BEING IMPOSED AFTER ADOPTION of
ENVIRONMENTAL SOLID WASTE PLANS

RESOLUTION

WHEREAS, Solid Waste, Landfill and associated costs are drastically increasing; and

WHEREAS, these costs create tremendous financial burdens on the budgets of County Governments; and

WHEREAS, many of these financial increases have been generated by the North Carolina Department of Environment, Health and Natural Resources, Department of Solid Waste, by an escalation of ongoing rules and requirements which continually change from administration to administration; and

WHEREAS, as a great number of these regulations require counties to expend funds when retroactive requirements are mandated, especially in the chemical element testing area; and

WHEREAS, the Department of Solid Waste has perpetuated the growth of Engineering, Geotechnical Testing and Hydrological Testing, as well as the proliferation of cost by these professionals for these specifics; and

WHEREAS, many of the requirements which are passed to counties appear as unfunded mandates with fines imposed when counties cannot meet requirements.

BE IT THEREFORE RESOLVED, we, the COLUMBUS COUNTY BOARD OF COMMISSIONERS, request the North Carolina Department of Environment, Health and Natural Resources, Division of Solid Waste, refrain from imposing new rules and regulations when County plans are adopted and that such practices, as retroactive tests, not be required unless the Division provides those funds for such operations and that costs, that in reality are unfunded mandates, not be imposed on local governments.
