#### RURAL WATER FUNDING

#### **RESOLUTION**

WHEREAS, having safe potable water is a quality of life concern for all citizens; and

WHEREAS, the ability to provide safe potable water has become a major concern for all rural county governments; and

WHEREAS, the number of elements that can and do pollute wells and water sources for drinking have increased; and

WHEREAS, the cost or providing water systems in rural areas has increased; and

WHEREAS, as average water bills for rural water systems are disproportionately higher than the municipal counterpart; an

WHEREAS, agencies that were developed for the major purpose of providing funds for rural water systems have had their funding reduced which directly affects counties' abilities to reduce grant dollars that would reduce the average water bill to a reasonable cost; and

WHEREAS, since the State of North Carolina has projected a billion dollars windfall above anticipated revenues.

THEREFORE, BE IT RESOLVED that the Columbus County Board of Commissioners requests that funds from the billion dollar windfall be set aside in a water fund that would be used specifically for providing grants to rural areas as additional funds for the development and construction of rural water systems allowing rural residents the ability of having safe and potable water.

### EMERGENCY MANAGEMENT SERVICES - REQUEST FOR HAZARDOUS MATERIAL TRAINING

Frank Carroll, Local Emergency Planning Committee, will address the Board regarding an appropriation of \$10,000 to be allocated for Hazardous Material Training as an incentive for volunteers.
