APPOINTMENT - BOARD OF SOCIAL SERVICES

A motion was made by Commissioner Norris, seconded by Commissioner Britt and passed unanimously to reappoint Commissioner C.W. Williams to serve on the Social Services Board of Directors for a three (3) year term, with term beginning July 1, 1998 and ending June 30, 2001.

AMBULANCE SERVICE PROVIDERS - REQUEST FOR PARAMEDIC-TYPE CARE TAKEN UNDER ADVISEMENT

Dr. William Elsaesser, Emergency Room Physician at Columbus County Hospital and Medical Director for County Rescue Squads, and Butch Meares, representing the County Rescue Squads, addressed the Board stating the County Rescue Squads have endorsed a plan to support pre-hospital emergency medical providers (rescue squads). Effective August 1, 1998, the North Carolina Office of Emergency Medical Services will rescind the EMT-Advanced Intermediate level of care which is the level that Columbus County Rescue Squads provide. The following recommendations are being presented by the Rescue Squads for the Board's consideration.

- 1. Maintain paid daytime personnel in each of the county's rescue squads to ensure timely response of basic life support and limited advanced life support and maintain all existing taxpayers' support for these rescue squads so they will be able to maintain the equipment and training necessary to continue the tradition of volunteer service.
- 2. Establish a paramedic level Quick Response Volunteer (QRV) system for the County, with four (4) QRV's strategically located throughout the County in order to provide timely, paramedic level care for appropriate patients. Rescue squads in the east, west, and southern areas of Columbus County will offer recommendations as to the location of QRV's there, with the fourth QRV to be located in the Whiteville area. The County could establish such a service of its own, or contract with a private EMS provider for this service.
- 3. Establish a system to help pay for this advanced care. Three (3) possible ways to generate revenue through this service is as follows:
 - a. Billing;
 - b. Taxes; or
 - c. Household fees.

Priscilla Long, Nakina Fire & Rescue Chief, reported that Nakina and Tabor

City Rescue Squads are against billing because they fear poor, elderly patients may be afraid to call because they can't afford the service.

A motion was made by Commissioner Williams, seconded by Commissioner

Jacobs and passed unanimously to take the request from the Columbus County Rescue

Squads under advisement.

AMBULANCE SERVICE PROVIDERS - MEETING TO BE SCHEDULED WITH COLUMBUS COUNTY HOSPITAL FOR THEIR INVOLVEMENT

A motion was made by Commissioner Wilson, seconded by Commissioner Norris and passed unanimously to direct Dempsey B. Herring, County Administrator, to schedule a special meeting with the Columbus County Hospital Board of Directors and request their involvement with the paid paramedics plan for Columbus County.
