# Division of Criminal Information (DCI) Management Control Agreement For Communication Centers Under A Law Enforcement Board

This Agreement made and entered into and between the Columbus Central

Law Enforcement Board and the Columbus Central Communication Center for the

purpose and consideration set forth:

#### I. Purpose

The purpose of this Agreement is to outline the requirements which must be followed in accessing the State Bureau of Investigation, Division of Criminal Information (DCI) Network directly, and in receiving the level of access to, but not limited, all National Crime Information Center files (wanted person, missing person, unidentified person, U.S. Secret Service Protective, stolen property, Canadian warrant, and Interstate Identification Index) and all DCI capabilities associated with Law Enforcement Agencies, including Computerized Criminal History and Criminal History Record Information.

### II. Membership of Board

Membership of this Law Enforcement Board will be the Chief of Police from local municipalities in Columbus County which are served by Columbus Central Communication Center. When a vacancy occurs, the appropriate municipality will appoint the chief when hired.

The following Law Enforcement/Criminal Justice Agencies compose the Columbus Central Law Enforcement Board:

Bolton Police Department
Chadbourn Police Department
Fair Bluff Police Department
Lake Waccamaw Police Department
Sandyfield Police Department
Tabor City Police Department
Whiteville Police Department

### III. Management Control Requirements

The Columbus Central Communication Center is under the management control of the Columbus Central Law Enforcement Board. Management control applies only to the operation of the DCI terminal and its access. The Law Enforcement Board is authorized to:

- 1) Set and enforce policies and priorities concerning use and operation of the DCI terminal and its access;
- 2) In accordance with the Columbus County Personnel Administrative Policy, the Board will recommend through the Emergency Services Director, personnel issues regarding hiring, supervising, suspending and dismissing employees relating to DCI issues;
- 3) Set and enforce policies regarding the operation of the communication center as it might affect access to the communication center, ensure compliance with rules and regulations of the communication center which affect law enforcement; and
- 4) The Columbus County Board of Commissioners may at any time, disband this Board.

I certify that I have read and understand the requirements of this Management Control Agreement and I will uphold this Agreement. All changes in management control will be promptly reported to the North Carolina State Bureau of Investigation, Division of Criminal Information.

This Agreement becomes effective on September 8, 1998.

### **RESOLUTION - SENATE BILL 421 OPPOSITION**

### In Opposition to a Proposed Freeze of Property Tax Values in 2000-01

WHEREAS, the Constitution of the State of North Carolina charges County

Governments with providing specific services to their citizens; and

WHEREAS, the ad valorem tax is the primary means available for most counties to generate the funds to pay for those services, in spite of the fact that the costs of providing those services continue to rise; and

WHEREAS, the General Statutes of the State of North Carolina provide that no county can charge an ad valorem tax rate higher than \$1.50 per \$100 in property valuation; and

WHEREAS, the General Statutes of the State of North Carolina also provide for Boards of Equalization and Review to consider appeals regarding the property revaluations which are mandated in eight-year cycles; and

WHEREAS, the Counties with limited tax bases already are severely constrained in their ability to grow by trying to keep their property tax rates as low as possible at the same time they seek to improve their citizens' quality of life; and

WHEREAS, the General Assembly has not heeded the call of counties in Eastern North Carolina to provide them with a menu of revenue options to reduce the burden on their citizens of paying ad valorem taxes; and

WHEREAS, a freeze on property tax values would cause a critical

deterioration in the quality of essential services provided by local government to their citizens and a resulting decline in economic viability of those same local governments.

THEREFORE BE IT RESOLVED, that the Columbus County Board of Commissioners opposes the passage of Senate Bill 421 (An Act to Amend the Constitution of North Carolina to Authorize the General Assembly to Enact Legislation Limiting the Valuation of Real Property for Property Tax Purposes to its Appraised Value on the 2000-01 Tax Bill and to Adjust the Appraised Value to Reflect its Sales Price When it is Sold), unless the General Assembly at the same time will remove the statutory limitation on ad valorem tax rates, and further enact legislation providing each and every County in North Carolina with optional sources of revenue in addition to the ad valorem tax, so the elected County officials in each County will have the opportunity to choose revenue options that will be most beneficial for their respective Counties.
